No licence authorising movement to any premises to which the Mitcham and District (Swine-Fever) Order of 1908 applies shall be issued under the said Order after the fifteenth day of July, nineteen hundred and eight, and any swine moved to any such premises with a licence under the said Order shall be kept separate from swine which have not been moved with any such licence.
