The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

### Transfer of Areas from one Scheduled Area to another.

1. From and after the commencement of this Order the Area firstly described in the First Schedule hereto shall, for the purposes of the Swine-Fever (Regulation of Movement) Order of 1908 and any modification of such Order which applies to the Scheduled Area secondly described in such Schedule, form part of that Area, and cease to form part of any other Scheduled Area.

2. From and after the commencement of this Order the Area firstly described in the Second Schedule hereto shall, for the purposes of the Swine-Fever (Regulation of Movement) Order of 1908 form part of the Scheduled Area secondly described in such Schedule, and cease to form part of any other Scheduled Area.

#### Commencement.

3. This Order shall come into operation on the seventeenth day of August, nineteen hundred and eight.
