AMERICAN GOUSEBERRY MILDEW (KENT) ORDER OF 1908 (No. 2).

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Destructive Insects and Pests Acts, 1877 and 1907, do order, and it is hereby ordered, as follows:

- 1. Notwithstanding the provisions of Article 6 of the American Gooseberry Mildew (Kent) Order of 1908 (hereinafter called the principal Order), a notice under that Article may require the occupier of infected premises to destroy by burning or other effective method and by a date to be specified in the notice any bush or bushes on the premises, and the Local Authority shall pay compensation for such destruction subject and according to the provisions in that behalf of the Destructive Insects and Pests Acts, 1877 and 1907.
- 2. This Order may be cited as the AMERICAN GOOSEBERRY MILDEW (KENT) ORDER OF 1908 (No. 2), and shall be read and construed with and as part of the principal Order.

SHEEP-SCAB (CARNARVONSHIRE DIPPING AREA) ORDER OF 1908.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Declaration of separate Sheep-Scab Compulsory Dipping Area in Carnarvonshire.

1. From and after the commencement of this Order the Area described in the Schedule hereto

is hereby declared to be a separate Compulsory Dipping Area for the purposes of the Sheep-Scab (Compulsory Dipping Areas) Order of 1906 and the Sheep-Scab (North Wales Dipping Areas) Order of 1908, and shall cease to form part of any other Compulsory Dipping Area, and those Orders shall apply to the first-mentioned Area operatingly, arbitation the paradical area. accordingly subject to the modifications contained in this Order.

Alteration of Periods for Compulsory Dipping.

2. In the Dipping Area declared by this Order the first prescribed dipping period shall commence on the first day of June and end on the thirtieth day of September, and the second prescribed dipping period shall commence on the first day of October and end on the thirtieth day of November.

## Commencement.

3. This Order shall come into operation on the twenty-fourth day of August, nineteen hundred and eight.

## Short Title.

4. This Order may be cited as the SHEEP-SCAB (CARNARYONSHIRE DIPPING AREA) ORDER OF 1908, and shall be read with the SHEEP-SCAB (NORTH WALES DIPPING AREAS) ORDER OF
