SPECIAL REGULATIONS respecting Open Competitive Examinations for Clerkships (Class I) in the Civil Service (supplementary to the General Regulations respecting Open Competitive Examinations for Situations in the Civil Service, included in Schedule A of the Order in Council of 4th June, 1870).

1. Candidates must have attained the age of 22 and must not have attained the age of 24 on the first day of August in the year in which the Examination is held,
