ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 20TH AUGUST 1908.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

The restrictions on movement of swine imposed by the Swine-Fever (Regulation of Movement) Order of 1908 shall not apply to the movement of swine from the sale mentioned in the Schedule hereto to any premises in Great Britain not being in a Swine-Fever Infected Place, if the swine are accompanied by a licence in the Form F set forth in the First Schedule to the said Order granted by an Inspector of the Local Authority of the District in which the place of destination is situate and subject to the following conditions:—

- (i.) The swine shall be moved to the place of destination specified in the licence and not elsewhere and shall be there detained and isolated from other swine for twenty-eight days, unless they are slaughtered on such premises before the expiration of that period,
- (ii.) The swine shall be moved by the nearest available route and without unnecessary delay, and during the movement shall, so far as is practicable, be kept separate from all swine not being moved with a licence under this Order.
- (iii.) After completion of the movement the licence shall forthwith be delivered up at, or sent by post to, the nearest police-station in the same District by the person in charge of the swine at the time of completing such movement.
