along that street to its junction with Halifax Old-road, thence in a south-easterly direction along Halifax Old-road to its junction with Bradford-road, thence across that road and along Willow-lane East and Hillhouse-road to Leedsroad, thence across that road and along Thistlestreet to St. Andrew's-road, thence across that road and along Hebble Beck to its junction with the River Colne, thence in a north-easterly direction along the said river to a point where the proposed new road in continuance of Old Fieldhouse-lane will meet the said river, thence in a north-westerly direction along the said proposed new road, Old Fieldhouse-lane and the road leading to Fieldhouse to the point first above described.

No. 5.-Dalton, Bradley and Deighton Ward.
