## Whitehall, October 5, 1908.

The KING has been pleased to grant unto Owen Lowry Wynne, of Avonbank, in the parish of Pershore and county of Worcester, and of the city of Dublin, Gentleman, Marshal of the High Court of Admiralty of Ireland, and to Harriott Julia Catherine, his wife, eldest daughter and co-heir of Henry Christopher Marriott, Esq., late of Avoubank aforesaid, sometime a Major in the 82nd Regiment of Foot, deceased, His Royal licence and authority that they may in compliance with a clause contained in an Indenture of Settlement, take and use the surname of Marriott in addition to and after that of Wynne,

and that he the said Owen Lowry Marriott may bear the arms of Marriott quarterly with his own family arms, and that such surname and arms may in like manner be taken, borne, and used by the issue of their marriage; such arms being first duly exemplified according to the Laws of Arms, and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect.

And also to command that the said Royal concession and declaration be recorded in His Majesty's College of Arms.
