## MOTOR CAR ACT, 1903.

## LIGHT RAILWAYS ACT, 1896.

The Board of Trade have recently confirmed the undermentioned Orders, made by the Light Railway Commissioners:—(1) Tickhill Light Railway (Amendment and Transfer) Order, 1908, extending the periods limited by the Tickhill Light Railway Order, 1901, as amended by the Tickhill Light Railway (Extension of Time) Order, 1904, for the compulsory purchase of lands, and for the completion of the railways and works thereby outhorized, and authorizing the transfer to the Great Northern Railway Company of the powers conferred by those Orders on the Tickhill Light Railway Company, and giving powers for the construction of additional lines, and for other purposes; (2) Barton and Immingham Light Railway Order, 1908, authorizing the construction of a light railway in the county of Lincoln (parts of Lindsey) from Barton to Immingham.

The Board of Trade have received a copy of the following Quarantine Notice, dated November 7th, issued by the Governor of Malta:-

## [No. 281.] GOVERNMENT NOTICE.

His Excellency The Governor, acting upon the advice of the Council of Health, has been pleased to order that Gövernment Notice No. 167 of August 28, 1908, shall be repealed and that the following Regulations shall be observed as regards the importation of the articles hereinafter mentioned, until further notice:—

1. The importation of the following articles is

prohibited:

(a) Coffee beans or ground coffee, coloured with substances injurious to health;

 (b) Vines and fruit packed in vine leaves.
 (c) Cotton seed, unless accompanied by a certificate from the British Consular Authority, or where there is no such authority, from the local Government Authority, to the effect that, anthrax is not prevalent in the district in which

such cotton seed was grown.

(d) Potatoes imported from England and Scotland, unless accompanied by a certificate from an officer of the Board of Agriculture stating that they are free from Black Scab and were not grown on land infected with that disease. Consignments of potatoes shipped before the publication of this notice shall be inspected on their importation by the Inspector of Agriculture, who may give such directions and take such steps as he may consider neces-

2. The importation of cuttings or shoots of the American or other vine is prohibited, unless' the goods are accompanied by an antiphylloxeric certificate, in accordance with the Berne International Conference of 1881, signed before a British Consular Authority, or unless the goods be subjected to examination and disinfection by the Inspector of Agriculture.

3. The importation of plants, roots or garden soil from any port in the Mediterranean is prohibited, unless the goods be accompanied by an antiphylloxeric certificate signed by the

proper authority.

4. Cereals imported in infected ships shall be kept for 21 days at the Lazaretto, or other place to be appointed by the Superintendent of Public Health, and shall be aired under the direction of the Quarantine Authorities.
5. The words "infected ships," in these

Regulations, have the same meaning as in the Regulations published by Government Notice

No. 165 of the 28th August, 1908.
