## Further Extension of Limits of Swine-Fever Infected Area.

1. The limits of the Swine-Fever Infected Area extended by Order of the Board dated the seventh day of November, nineteen hundred and eight, are hereby further extended so as to comprise the Area described in the Schedule to this Order, and the Area so described is hereby declared to be a Swine-Fever Infected Area for the purposes of the Swine-Fever (Regulation of Movement) Order of 1908.

### Commencement.

2. This Order shall come into operation on the sixteenth day of November, nineteen hundred and eight.
