W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His late Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her late Majesty Queen Victoria, chapter forty-nine; of the Act of the eleventh and twelfth years of Her said late Majesty, chapter thirty-seven; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, duly prepared and laid before His Majesty in Council a representation, bearing date the fifth day of November, in the year one thousand nine hundred and eight, in the words following, that is to say :--

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fiftyninth year of His late Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her late Majesty Queen Victoria, chapter forty-nine; of the Act of the eleventh and twelfth years of Her said late Majesty, chapter thirty-seven; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, have prepared, and now humbly lay before Your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church of Saint Barnabas, situate at Newcastle-upon-Tyne, in the new parish (sometime particular district) of Jesmond, in the county of Northumberland and in the diocese of Newcastle.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Barnabas, situate at Newcastle-upon-Tyne as aforesaid.

"Now therefore, with the consent of the Right Reverend Norman Dumenil John, Bishop of the said diocese of Newcastle (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent that it would, in our opinion, be expedient that all that part of the said new parish of Jesmond which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint Barnabas, situate at Newcastle-upon-Tyne as aforesaid, and that the same should be named 'The District Chapelry of Saint Barnabas, Newcastle-upon-Tyne.'
