

should be abolished and that its constituent Civil Parishes should be added to other Sub-districts of that Registration District in the following manner. viz.:—(1) that Alpheton and Long Melford Civil Parishes should be transferred to Hartest Sub-district; (2) that Liston and Borley Civil Parishes should be transferred to Bulmer Sub-district; and (3) that Acton, Great Waldingfield, Little Waldingfield and Newton Civil Parishes should be transferred to Bures Sub-district; (b) that Pentlow and Foxearth Civil Parishes should be transferred from Hartest Sub-district to Bulmer Sub-district; (c) that Middleton, Great Henny, and Little Henny Civil Parishes should be transferred from Sudbury Sub-district to Bulmer Sub-district; (d) that Lamarsb, Alphamstone, and Bures Civil Parishes should be transferred from Bures Sub-district to Bulmer Sub-district; (e) that Little Cornard Civil Parish should be transferred from Sudbury Sub-district to Bures Sub-district; and (f) that Hartest Sub-district should be re-named Melford Sub-district;

2. Now, therefore, I, Sir William Gospatrick Dunbar, Bart., C.B., Registrar-General of Births, Deaths, and Marriages in England, in exercise of the powers given me by the above mentioned Act, and with the sanction of the Local Government Board, do hereby order and declare that the foregoing alterations shall take effect accordingly.

3. This Order shall come into operation on the first day of February, nineteen hundred and nine.

The heights given are above high water.]

**No. 115.—RED SEA—STRAITS OF BAB
EL MANDEB.**

Perim Island—Instructions for Night-Signalling.

Subject.—The undermentioned instructions have been issued for the guidance of vessels wishing to signal at night to Perim Island.

Position.—Lower Signal Station, lat. 12° 39' N., long. 43° 24' E.

1. Vessels when wishing to signal at night to Perim Island should pass through the Large Strait, and signal to the Lower Signal Station, on the south-western side of the island.

2. Vessels outward bound wishing to communicate by night signal with this station should commence to attract the notice of the station before they get abeam of Balfa Point Light, in order to afford the station sufficient time to get ready to receive the signal.

3. If the signalling be made by flashing lamp, care should be taken to keep the lamp pointing direct to the station, and to screen all other lights near it whilst it is being used.

4. At night, the position of the Lower Signal Station will be marked by two red lights.
