consent of the said Thomas Craven (in testimony of which consent he has signed and sealed this scheme) we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole advowson or perpetual right of patronage of and presentation to the said benefice of Kirklington and the church thereof shall be assigned and transferred from the said William Boyd, Bishop of Ripon, and from his successors in the same bishoprick, and shall become and be absolutely vested in and shall and may from time to time and at all times be exercised by the said Thomas Craven his heirs and assigns for

ever and that in exchange for the same the whole advowson or perpetual right of patronage of and presentation to the said benefice of Hockerton and the church thereof shall in like manner and upon and from the same date be assigned and transferred from the said Thomas Craven his heirs and assigns and shall become and be absolutely vested in and shall and may from time to time and at all times be exercised by the said William Boyd, Bishop of Ripon, and his successors in the same bishoprick for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of either of them or of any other Act of

Parliament.
