THE FAIRS ACT, 1873. BRECON FAIRS.

The Secretary of State for the Home Department hereby gives notice that a representation has been duly made to him by the Brecon Town Council, to the effect that it would be for the convenience and advantage of the public that the Stock Fairs which have been held annually at Brecon on two consecutive days (namely the first Tuesday and the following Wednesday) in the months of May and November respectively, should in future be held on the first Tuesday and the following Wednesday, Thursday and Friday, in each of the said months.

On the 12th day of April, 1909, the Secre-tary of State will take such representation into consideration, and any person who may desire to object to the alteration of the dates for the holding of the said Fairs should intimate his objections to the Secretary of. State before that day.
