(c) In the said churchyard, in grave spaces in which no interment has heretofore taken place, the burial may be allowed of the bodies of Mrs. Gertrude Lucas-Calcraft and Mr. William Baker, at their decease, and of one member of the family of Mr. Cragg, subject to the condition that no part of the coffin containing the body shall in any case be at a depth less than three feet from the level of the surface of the ground adjoining the grave.

The KING's Most Excellent Majesty in Council.

WHEREAS the Local Government Board, after giving to the Incumbent and the Churchwardens of the parish of Saint Mary Tavy, in the county of Devon, ten days' previous notice of their intention to make such representation, have, under the provisions of the Burial Act, 1853, made a representation stating that, for the protection of the public health, no new burial ground should be opened in the civil parish of Mary Tavy without the previous approval of the Local Government Board, and that burials should be discontinued therein, as follows, viz.:-

MARY TAVY, DEVONSHIRE.—Forthwith and entirely in the parish church of Saint Mary Tavy; and in that portion of the churchyard attached thereto which was in use prior to the year 1879, except as follows:—

(a) In any vaults or walled graves now existing in the said portion of the churchyard the burial may be allowed of the bodies of Eliza Cole, Elizabeth Ann James, Mary Oxenham, William Dawe and James Maunder at their decease subject to the condition that every coffin buried in such vault or grave be separately enclosed by stonework or brickwork properly cemented:

(b) In the earthen grave now existing in the said portion of the churchyard in which the body of John Mitchell is interred, the burial may be allowed of the body of Jane Mitchell, at her decease subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

Now, therefore, His Majesty in Council is pleased hereby to give notice of such representation, and to order that the same be taken into consideration by a Committee of the Lords of His Majesty's Most Honourable Privy Council on the twenty-eighth day of June next.

And His Majesty is further pleased to direct that this Order be forthwith published in the

London Gazette, and that copies thereof be affixed on the doors of the churches or chapels of, or on some conspicuous places within, the parish affected by such representation one month before the said twenty-eighth day of June.
