LIGHT RAILWAYS ACT, 1896.

Blackburn, Whalley and Padiham Light Railways (Revival and Extension of Time) Order.

The Light Railway Commissioners have submitted to the Board of Trade for confirmation, under the above-mentioned Act, an Order made by them reviving the powers granted by the Blackburn, Whalley and Padiham Light Railways Order, 1901, and extending the period limited by that Order for the compulsory purchase of lands, and for completion of the railways and works thereby authorised and for other purposes.

Any objections to the confirmation of the Order should be addressed to the Assistant-Secretary (Railway Department), Board of Trade, Whitehall Gardens, London, S.W., and must be lodged with the Board on or before the 7th June, 1909.
