#### MOTOR CAR ACT, 1903.

##### County of Carnarvon.

Whereas by sub-section 1 of section 9 of the Motor Car Act, 1903, it is enacted that within any limits or place referred to in regulations made by the Local Government Board with a view to the safety of the public, on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a car at a speed exceeding ten miles per hour:

Notice is hereby given, that the County Council of Carnarvon have made application to the Local Government Board for a regulation to be made in pursuance of the said sub-section putting the above-mentioned provisions of that sub-section in force within the limits comprising the following roads or parts of roads within the urban district of Bettwsycoed, that is to say:—

So much of the main road passing through the village of Bettwsycoed as extends from Arvon House or Pyllau to the place known as Cross Keys at the Capel Curig end of the village; and

The road or street known as Mill-street, extending from the turning or bend under Tanybryn to its junction with the main road aforesaid.

Notice is hereby further given that objections to the making of any such regulation may be sent in writing to the Local Government Board at their offices at Whitehall, London, on or before the twelfth day of June, 1909.

A copy of any such objection should be sent at the same time by the objector to the County Council, addressed to the Clerk to the County Council of Carnarvon, County Offices, Carnarvon. Dated this twenty-second day of May, 1909.
