THE TORQUAY TRAMWAYS COMPANY Limited hereby give notice that, under the powers conferred on the Company by the Tramways Act, 1870, the following BYE-LAWS and REGULATIONS shall, subject to the final approval of the Board of Trade, come into force on the third day of July, 1909:—

1. The Bye-laws and Regulations hereinafter set forth shall extend and apply to all the tramway cars and tramway carriages (afterwards in these Bye-laws and Regulations called "cars") of the Torquay Tramways Company Limited (hereinafter called "the Company") and to all places with respect to which the Company, acting under the Tramways Act, 1870, have power to make Bye-laws or Regulations.

2. Every passenger shall enter or depart from a car by the conductor's platform in the rear of the car, and not otherwise. When a car stops, no person shall board the car until all passengers desiring to alight therefrom shall have done so.

3. Every passenger shall, upon demand, pay to the conductor, or other duly authorised officer of the Company, the fare legally demandable for the journey, and a ticket corresponding thereto shall be delivered to such passenger by the
