#### MOTOR CAR ACT, 1908.

##### County of London.

Whereas by sub-section (1) of section 9 of the Motor Car Act, 1908, it is enacted that within any limits or place referred to in regulations made by the Local Government Board with a view to the safety of the public, on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour:

Notice is hereby given that the London County Council have made application to the Local Government Board for a regulation to be made in pursuance of the said sub-section putting the above-mentioned provisions of that sub-section in force within the limits comprising so much of Heath-street, Hampstead, as extends from its junction with High-street to a point situate 80 yards north of its junction with Hampstead-square.

Notice is hereby further given that objections to the making of any such regulation may be sent in writing to the Local Government Board, at their offices in Whitehall, London, on or before the twenty-fourth day of June, 1909.
