thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of All Saints, Sydenham, situate as aforesaid, and that the same should be named 'The District Chapelry

of All Saints, Sydenham.'

"And with the like consent of the said Edward Stuart, Bishop of Southwark (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published and that marriages. baptisms, churchings, and burials should be solemnized or performed at the said church of All Saints, Sydenham, situate as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the Minister of the same church for the time being: Provided always that nothing herein contained shall be construed as expressing any intention on the part of us, the said Commissioners, to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in Your Parallel and the Parallel and Parallel and

in Your Royal wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of All Saints, Syden-

ham, being:--

" All that part of the new parish (sometime consolidated chapelry) of Saint Michael and All Angels, Bell Green, Lower Sydenham, in the county of Kent and in the diocese of Southwark, which is bounded upon the north-west by the district parish of Christ Church, Forest Hill, upon the west by the district parish of Saint Bartholomew, Sydenham, upon the south by the new parish of the Holy Trinity, Penge-lane, all in the said county and diocese, and upon the remaining side, that is to say, upon the east, by an imaginary line commencing at a point where the boundary which divides the said new parish of the Holy Trinity, Penge-lane, from the said new parish of Saint Michael and All Angels, Bell Green, Lower Sydenham, crosses the wall or fence forming the eastern boundary of the houses and premises on the eastern side of the road called Fairlawn Park, and extending thence northward along the said wall or fence for a distance of eight chains or thereabouts to the point where the said wall or fence forms the western boundary of the Home Park Recreation Ground, and extending thence first north-westward, then south-westward, then again north-westward, and then north-eastward along the wall or fence forming the western boundary of the said recreation ground for a distance of thirteen chains or thereabouts to the point where such wall or fence meets the south-eastern side of Sydenham - road, and extending thence first north-westward to and then south-westward along the middle of Sydenham-road, for a distance of four chains and a half or thereabouts to its junction with Highelere-street, and extending thence first north-westward, then westward, and then northward along the middle of Highelere-street for a distance of fifteen chains and a quarter or thereabouts to its junction with Burghill-road, and extending thence eastward along the middle of Burghillroad for a distance of four chains or thereabouts to its junction with the road called Championcrescent, and extending thence first northward, and then north-eastward, along the middle of

Champion-crescent for a distance of one chain or thereabouts to a point opposite to the southern end of the wall forming the western boundary of the premises belonging to the Saint Michael and All Angels Infants' School, and extending thence first north-westward to and then northward along the said wall for a distance of two chains and a half or thereabouts to its northern end on the southern side of Adamsrill-road, and extending thence north-westward in a straight line diagonally across Adamsrill-road for a distance of fifteen yards or thereabouts to the southern end of the wall or fence forming the eastern boundary of the house and premises known as Numbers 55 and 57, Adamsrill-road, and extending thence northward along such wall or fence for a distance of one chain and a half or thereabouts to its northern end, and extending thence northward in a straight line for a distance of ten chains or thereabouts to the junction of the passage running along the backs of the bouses and premises on the southern side of Queenswoodroad with the passage running between the houses known as Number 46 and Number 44, Queenswood-road, and extending theuce north-ward along the middle of the last-mentioned passage for a distance of one chain and a half or thereabouts to the point where it meets the southern side of Queenswood-road, and extending thence in a straight line diagonally across Queenswood-road for a distance of fourteen yards or thereabouts to a point in the middle of the southern end of the roadway running between the houses known as Number 41 and Number 35, Queeuswood-road, and extending thence northward along the middle of such roadway for a distance of one chain and a half or thereabouts to its junction with the roadway running along the backs of the houses and premises on the northern side of Queenswood-road, and extending thence northward in a straight line for a distance of six chains or thereabouts to the south-western corner of the westernmost of the houses known as Shaw's Cottages and extending thence northward along the western side of the said house for a distance of half a chain or thereabouts to its north-western corner, and extending thence in precisely the same direction and in a straight line for a distance of half a chain or thereabouts to a point in the middle of the footpath on the northern side of Shaw's Cottages upon the boundary which divides the said new parish of Saint Michael and All Angels, Bell Green, Lower Sydenham, from the said district parish of Christ Church, Forest Hill."

And whereas the said representation has been approved by His Majesty in Council: now, therefore, His Majesty by and with the advice of His said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Southwark.

for England have, in pursuance of the
Act of the fifty-ninth year of His late Majesty
King George the Third, chapter one hundred and
