thirty-four; of the Act of the second and third years of Her late Majesty Queen Victoria, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, duly prepared and laid before His Majesty in Council a representation, bearing date the thirteenth day of May, in the year one thousand nine hundred and nine, in the

words following, that is to say:-

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His late Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her late Majesty Queen Victoria, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, have prepared, and now humbly lay before Your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church of Saint Anne, situate at Brislington, in the parish of Brislington, in the county of Somerset and in the diocese of Bath and Wells.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Anne, situate at Brislington as

aforesaid.

"Now therefore, with the consent of the Right Reverend George Wyndham, Bishop of Bath and Wells (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent that it would, in our opinion, be expedient that all that part of the said parish of Brislington, which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint Anne, situate at Brislington as aforesaid, and that the same should be named 'The District Chapelry of

Saint Anne, Brislington.'

"And with the like consent of the said George Wyndham, Bishop of Bath and Wells (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said church of Saint Anne, situate at Brislington as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us, the said Commissioners, to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in

Your Royal wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Anne,

Brislington, being:-

"All that part of the parish of Brislington, in the county of Somerset and in the diocese of Bath and Wells, which is bounded upon the east, and upon the north by the consolidated chapelry of Saint Aidan, Bristol, upon the north-west partly by the new parish of Saint George, partly by the new parish of Saint Luke, Barton Hill, and partly by the new parish of Saint Silas,

Bristol, all in the county of Gloucester and in the diocese of Bristol, upon the south-west and upon part of the south by the new parish of the Holy Nativity, Knowle, in the said county of Somerset and in the said diocese of Bristol, and upon the remaining sides, that is to say, upon the remaining part of the south and upon the south-east, by an imaginary line commencing at the point where the boundary which divides the said new parish of the Holy Nativity, Knowle, from the said parish of Brislington crosses the middle of Bath-road, and extending thence eastward along the middle of Bath-road for a distance of sixteen chains or thereabouts to its junction with Sandy Park-road, and extending thence south-eastward along the middle of Sandy Park-road for a distance of fifteen chains or thereabouts to its junction with Sandhurst-road, and extending thence north-eastward along the middle of Sandhurst-road for a distance of six chains and a half or thereabouts to its junction with Sandownroad, and extending thence north-westward along the middle of Sandown-road for a distance of one chain or thereabouts to its junction with Upper Sandhurst-road, and extending thence north-eastward along the middle of Upper Sandhurstroad for a distance of five chains or thereabouts to its junction with Sandwich-road, and extending thence south-eastward along the middle of Sandwich-road for a distance of six chains and a quarter or thereabouts to its junction with Sandringham-road, and extending thence northward along the middle of Sandriugham-road for a distance of five chains or thereabouts to its junction with Upper Sandhurst-road, and extending thence eastward along the middle of Upper Sandhurst-road for a distance of four chains and a half or thereabouts to its junction with Wickroad upon the boundary of the county borough of Bristol, and extending thence first north-east-ward and then in various directions along the said boundary (thereby following in part the middle of Wick-road, the middle of First-avenue and the middle of Saint Anne's Park-road) for a distance of one mile or thereabouts to the point where such boundary turns south-westward along the northern bank of the River Avon, and extending thence south-eastward in a straight line for a distance of fifteen yards or thereabouts to the point in the middle of the River Avon where the boundaries of the said parish of Brislington, the parish of Hanham, in the said county of Gloucester and in the said diocese of Bristol, and the said consolidated chapelry of Saint Aidan, Bristol, all meet."

And whereas the said representation has been approved by His Majesty in Council: now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Bath and Wells.
