of military maneuvres within specified limits during a specified period not exceeding three months.

Now, therefore, His Majesty, by and with the advice of His Privy Council, by virtue of the power for this purpose given to His Majesty by the said Act, and of every other power hereunto enabling, His Majesty doth hereby authorize the execution of military manœuvres within the limits specified in the Schedule to this Order during the period of three calendar months commencing from the fifteenth day of July, one thousand nine hundred and nine.

And the Right Honourable the Principal Secretary of State for the War Department is to give the necessary directions herein accordingly.

THE SCHEDULE.

All that area of land comprising portions of the counties of Gloucester, Wilts, Oxford, Berks, Hants, Warwick and Worcester, lying within a line drawn—

On the north, from Evesham along the road through Bengeworth, Bretforton, by Weston Sub-edge Railway Station to Aston Sub-edge and thence to Chipping Campden; thence following the road by Campden Station to Ebrington and Shipston-on-Stour, Upper Brailes, Lower Brailes, Swalcliffe, Broughton, to Banbury.

On the east, from Banbury along the road towards Aynho, to the county boundary of Oxford and Northampton; thence following the county boundary by Clifton to Souldern, and thence by the road to Caversfield and Bicester, thence by Wendlebury to Islip, thence by Stanton Saint John, Wheatley, and Tetsworth, and towards Stokenchurch up to the county boundary between Oxford and Bucks; thence following the county boundary to the river Thames at Fawley; thence by the county boundary between Oxford and Berks along the river Thames to Caversham Bridge and Reading; thence through Reading by the Caversham-road, West-street, Saint Mary's Butts, Bridge-street, Southampton-street, Whitley-street, and Basing-stoke-road to Riseley Common, and thence by Sherfield to Basingstoke.

On the south, from Basingstoke by Deane, Overton, to Whitchurch, thence in a northwesterly direction along the road by Saint Mary Bourne, Hurstbourne Tarrant, Upton, Vernhams Dean, Fosbury, Oxenwood, to North Hill, then turning west past the Nag's Head Public House to East Grafton, and by Grafton and Burbage Railway Station past Burbage, Easton, Milton Lilburne to Pewsey, thence along the road by Manningford Bruce, and by Upavon to the boundary of the War Department land on Salisbury Plain; thence following the War Department boundary westward towards Urchfont Hill and thence south by Church Hill to New Farm; thence by the road in a north-westerly direction to Market Lavington, and thence by the road by Potterne to Devizes, and thence following the Kennet and Avon Canal to the county boundary between Wilts and Somerset; thence following the said county boundary to the point where the county boundaries of Wilts, Gloucester, and Somerset meet; and thence following the county boundary between Somerset and Gloucester to the Midland Railway in the parish of Bitton.

On the west, from the point where the Midland Railway from Bath to Gloucester cuts the county boundary between Gloucester and Somerset, and following the said railway to Wickwar and Gloucester, thence following the course of the river Severn to Tewkesbury, and thence

along the road viâ Aston-under-Hill to Evesham, and which area, surrounded on all sides by a red line, is delineated on a map signed by His Majesty's Principal Secretary of State for the War Department, copies of which are deposited in the War Office and the Privy Council Office.

The following Statute made by the Governing Body of Magdalen College, Oxford, on the 1st day of February, and the 26th day of May, 1909, amending certain of the Statutes of the College, has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions contained in "The Universities of Oxford and Cambridge Act, 1877":—

STATUTE to amend the existing Statutes of Magdalen College in the University of Oxford, duly made at General Meetings of the President and Fellows especially summoned for this purpose on the first day of February and the twenty-sixth day of May, one thousand nine hundred and nine respectively, and passed at such meetings by the votes of two-thirds of the number of persons present and voting, and submitted to His Majesty the King in Council.

Statute for Magdalen College made by the College under the Universities of Oxford and Cambridge Act, 1877.

Preliminary.

This Statute is supplementary to the existing Statutes of the College, that is to say, the Statutes dated the 16th day of June, 1881, made for the College by the University of Oxford Commissioners (hereinafter referred to as the Statutes of 1881), as altered by the Statutes dated the 10th day of August, 1888, the Statutes dated the 7th day of March, 1899 (hereinafter referred to as the Statutes of 1899), the Statutes

dated the 15th day of September, 1902, and the Statutes dated the 10th day of May, 1905, made by the College under the Universities of Oxford and Cambridge Act, 1877.

Chapel Services.

So much of the clause numbered 3 of the Statutes of 1881 as to Chapel Services as relates to the right of Chaplains to occupy rooms in College rent free is hereby repealed, but such repeal shall not affect such right of any Chaplain appointed before the date of the approval of this Statute by His Majesty in Council. The President and Fellows may if they so think fit assign rooms rent free to any Chaplain.

Pensions.

Every Tutor appointed after the date of the approval of this Statute by His Majesty in Council shall vacate his Tutorship on attaining the age of 60 or, if he shall not then have completed fifteen years of service, so soon thereafter as he shall have completed that term, and shall
