Additional Order made in pursuance of the Metropolitan Public Carriage Act, 1869 (32 and 33 Vict., cap. 115).

In pursuance of section 8 of the Metropolitan Public Carriage Act, 1869, I hereby prescribe as follows:—

1. In addition to the licences mentioned in paragraph 15 of the Order dated 30th December, 1907, licences may upon the special application of a proprietor, be granted to persons to act either as driver or conductor of a Metropolitan Stage Carriage.

2. Licences so granted shall be in the form contained in the schedule to this Order.

3. The sum to be paid for each licence issued under this Order shall be 5s.

4. This Order shall come into force on the first day of July, 1909, and shall be construed as one with Part II of the Order made by me, dated the 30th December, 1907. Whitehall. 29th June, 1909. H. J. Gladstone.
