direct as if the words and figures set forth in the second column of the said schedule opposite to the reference to that section in the first column of that schedule were added to and formed part of the section.

## SCHEDULE.

Parts and Sections. Conditions and Adaptations. 1.

PART II. Section twenty-five. "The power of making or

enforcing bye-laws under section one hundred and fifty-seven of the Public Health Act, 1875, as extended by section twentythree of the Public Health Acts Amendment Act, 1890, with respect to the paving of yards and open spaces in connection with dwelling - houses, cease to be exercisable."

Section twentyseven.

"(7) Nothing in this section shall apply to any temporary building erected or set up for use by the Territorial Force."

PART III:

Section thirty-five. "This section, so far as it relates to the deposit of material, shall have effect subject to the first proviso to section ninety-one of the Public Health Act,

> "The power of making or enforcing bye-laws under section twenty-three of the Municipal Corporations Act, 1882, for the prevention and suppression of nuisances shall not be exercisable in relation to any subject-matter of this section.

Section thirtyeight.

"Nothing in this section shall prejudicially affect any power or right exercisable by or attach-ing to an owner or occupier of premises by virtue of section twenty-two of the Public Health Act, 1875, or of section eighteen of the Public Health Acts Amendment Act, 1890."

PART IV. Section fifty-nine.

"(6) Nothing in this section shall apply to a public or circulating library which is not within the district."

PART V. Section seventyfive.

"(3) The date of the Order of the Local Government Board by which this Part is declared to be in force shall be the beginning of the period within which the Local Authority shall give notice for the purposes of sub-section (1) of this section."
