MOTOR CAR ACT, 1903.

County of Kent.

Whereas by section 8 of the Motor Car Act, 1903 (hereinafter referred to as "the Act of 1903"), it is enacted that the Local Government Board may by regulations made under section 6 of the Locomotives on Highways Act, 1896 (hereinafter referred to as "the Act of 1896"), prohibit or restrict the driving of any motor cars, or of any special kind of motor cars, on any specified highway or part of a highway, which does not exceed sixteen feet in width, or on

which ordinary motor car traffic would, in their opinion, be especially dangerous:

And whereas by sub-section 1 of section 9 of the Act of 1903, it is enacted that within any limits or place referred to in regulations made by the Local Government Board with a view to the safety of the public, on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour:

Notice is hereby given that the County Council of Kent have applied to the Local Government Board to make regulations:—

(a) Under section 6 of the Act of 1896 and section 8 of the Act of 1903, for prohibiting the driving of motor cars along the road known as Church-lane, situate in the urban districts of Chislehurst and Footscray; and

(b) Under sub-section 1 of section 9 of the Act of 1903 putting the above-mentioned provisions of that sub-section in force within the limits comprising the following roads or parts of roads within the urban district of Beckenham, that is to say:—

High-street; and

So much of Scott's-lane as extends from its junction with Bromley-road to its junction with Oakwood-avenue:

Notice is hereby further given, that objections to the making of either of such regulations may be sent in writing to the Local Government Board, at their offices at Whitehall, London, on or before the 13th day of August, 1909.

A copy of any such objection should be sent at the same time by the objector to the County Council, addressed to the Clerk to the County Council of Kent, Sessions House, Maidstone.
