said late Majesty, chapter ninety-seven; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five; duly prepared and laid before His Majesty in Council a representation, bearing date the tenth day of June, in the year one thousand nine hundred and nine, in the words and figures following, that is to say:-

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy, of the Act of the fourteenth and fifteenth years of Her said late Majesty, chapter ninety-seven, and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, have prepared, and now humbly lay before Your Majesty in Council the following representation as to the assignment of a consolidated chapelry to the consecrated church of the Holy Trinity, Nordelph, situate within the parish of Upwell Saint Peter, partly in the county of Norfolk and partly in the county of Cambridge and wholly in the diocese of Norwich.

"Whereas at certain extremities of the said parish of Upwell Saint Peter, of the parish of Outwell, partly in the said county of Norfolk and partly in the said county of Cambridge and wholly in the said diocese of Norwich, of the parish of Stow Bardolph, of the parish of Wimbotsham, of the parish of Downham, and of the parish of Denver, all in the said county of Norfolk and in the said diocese of Norwich, which said extremities lie contiguous one to another, and are described in the schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such parishes.

"And whereas it appears to us to be expedient that certain contiguous portions (being the portions containing the population aforesaid) of the said parish of Upwell Saint Peter, of the said parish of Outwell, of the said parish of Stow Bardolph, of the said parish of Wimbotsham, of the said parish of Downham, and of the said parish of Denver, should be formed into a con-solidated chapelry for all ecclesiastical purposes, and that the same should be assigned to the said church of the Holy Trinity, Nordelph, situate as

"Now, therefore, with the consent of the Right Reverend John, Bishop of Norwich, as such Bishop, and also as the patron of the rectory of the said parish of Outwell, with the consent of the Reverend Charles Francis Townley of Christ Church Rectory, Wisbech, in the said county of Cambridge, Clerk in Holy Orders, as the patron of the rectory of the said parish of Upwell Saiut Peter, with the consent of Sir Thomas Leigh Hare, Baronet, of Stow Hall, Downham Market, in the said county of Norfolk, as the patrom of the vicarage of the said parish of Stow Bardolph as well as of the rectory of the said parish of Wimbotsham, with the consent of the Reverend Herbert Edward Jones of the Vicarage, Hitchin, in the county of Hertford, Clerk in Holy Orders, as the patron of the rectory of the said parish of Downham (in testimony whereof the consenting parties above mentioned have respectively signed and sealed this representation), and with the consent of the Master and Fellows of Gonville and Caius College, in the University of Cam-bridge as the patons of the rectory of the said parish of Denver (in testimony whereof they have caused their common or corporate seal to be affixed to this representation) we, the said Ecclesiastical Commissioners for England, humbly represent, that it would, in our opinion, be expedient that all those contiguous portions of thence first eastward to and then south-eastward

the said parish of Upwell Saint Peter, of the said parish of Outwell, of the said parish of Stow Bardolph, of the said parish of Wimbotsham, of the said parish of Downham and of the said parish of Denver, which are described in the schedule hereunder written, all which portions together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of the Holy Trinity, Nordelph, situate as aforesaid, and that the same should be named 'The Consolidated Chapelry of the Holy Trinity, Nordelph.

"We therefore humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration, and to make such Order in respect thereto as to Your Majesty in Your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The consolidated chapelry of the Holy Trinity, Nordelph, comprising:

"All those contiguous portions of the parish of Upwell Saint Peter, of the parish of Outwell, both partly in the county of Norfolk and partly in the county of Cambridge and wholly in the diocese of Norwich, of the parish of Stow Bardolph, of the parish of Wimbotsham, of the parish of Downham and of the parish of Denver, all in the said county of Norfolk and in the said diocese of Norwich, which, taken together, are comprised within and are bounded by an imaginary line commencing at the centre of Angle Bridge which carries the road leading from Upwell past the Crooked Chimney Inn towards Widder's Farm across the Middle Level Drain and extending thence first eastward, then southward and then again eastward along the middle of the said road (thereby crossing the boundary which divides the said parish of Outwell from the said parish of Stow Bardolph) for a distance of one mile or thereabouts to its present eastern end, and extending thence first southward to and then eastward along the middle of the drain forming the northern boundary of the closes numbered 1, 2, 3 and 4 upon the map or plan annexed to this representation for a distance of twenty-six chains or thereabouts to the point where such drain meets the drain forming the western boundary of the house and premises attached to Widder's Farm, and extending thence first northward, then eastward and then southward along the middles of the drains and the fences forming the western, northern and eastern boundaries of the said house and premises for a distance of thirteen chains or thereabouts to the point where the drain forming the eastern boundary of such house and premises meets the drain forming the northern boundary of the closes numbered 5 and 6 upon the said map or plan, and extending thence eastward along the middle of the last-mentioned drain for a distance of twenty-two chains or thereabouts to the point where such drain meets the drain forming the western boundary of the close numbered 7 upon the said map or plan, and extending thence first north-westward along the middle of the last-mentioned drain and then eastward along the middle of the drain forming the northern boundary of the said close numbered 7 and of the closes numbered 8 and 9 upon the said map or plan for a distance of forty-eight chains or thereabouts to the point where the last-mentioned drain meets the drain on the western side of the road called the Chase (upon the boundary which divides the said parish of Stow Bardolph from the said parish of Downham), and extending
