along the middle of the Chase for a distance of | River, and extending thence north-westward in twenty-eight chains or thereabouts to its junction with the road called Barroway Drove, and extending thence north-eastward along the middle of Barroway Drove for a distance of eight chains and a half or thereabouts to its junction with the road called Lady Drove, and extending thence south-eastward along the middle of Lady Drove for a distance of forty chains or thereabouts to the point where it crosses the middle of the drain running along the southern side of the Wash Bank, and extending thence south-westward along the middle of the last-mentioned drain for a distance of thirty-one chains or thereabouts to the point where such drain meets the drain running past the north-eastern side of Slate Farm House, and extending thence south-eastward along the middle of the last-mentioned drain for a distance of forty-one chains or thereabouts to the point where such drain abuts upon the northeastern side of the roadway leading from Slate Farm House past Bank House Farm House into the road leading from Nordelph to Downham Market, and extending thence first south-westward to and then first south-eastward and then southward along the middle of the said roadway for a distance of thirty-four chains or thereabouts to its junction with the said road leading from Nordelph to Downham Market, and extending thence eastward along the middle of such road for a distance of three chains and a half or thereabouts to the point where such road meets the embankment on the north-western side of the River Ouse, and extending thence first south-eastward to and then first south-westward and then southward along the middle of the River Ouse (thereby following for a short distance the boundary which divides the said parish of Downham from the said parish of Denver) for a distance of forty-six chains or thereabouts to its junction near Denver Sluice with the New Bedford River or Hundred Foot Drain, and extending thence south-westward along the middle of such river or drain for a distance of one mile and sixty-two chains or thereabouts to the point where it is crossed by the boundary which divides the said parish of Denver from the said parish of Upwell Saint Peter and extending thence south-eastward along the last-mentioned boundary for a distance of nineteen chains or thereabouts to the point where it meets the boundary which divides the parish of Fordham, in the said county of Norfolk and in the said diocese of Norwich, from the said parish of Upwell Saint Peter, and extending thence south-westward along the lastmentioned boundary (thereby following the centre of the Old Mail Lode) for a distance of fifty-two chains or thereabouts to the point where it meets the boundary which divides the parish of Hilgay, in the said county of Norfolk and in the said diocese of Norwich, from the said parish of Upwell Saint Peter, and extending thence north-westward along the last-mentioned boundary (thereby crossing the New Bedford River or Hundred Foot Drain) for a distance of six chains or thereabouts to the point on the north-western side of the said river or drain where the last-mentioned boundary meets the boundary which divides the parish of Welney, partly in the said county of Norfolk and partly in the said county of Cambridge and wholly in the diocese of Norwich, from the said parish of Upwell Saint Peter, and extending thence first generally north-westward and then south-westward along the last-mentioned boundary (thereby following in part the middle of the Old Bedford River) for a distance of one mile and twenty-six chains or thereabouts to the point where such boundary leaves the middle of the Old Bedford

a straight line (thereby passing to the north-east of Cock Fen Farm House) for a distance of one mile and fifty-two chains or thereabouts to a point in the middle of the eastern end of the road called Horse Head Drove, and continuing thence north-westward in precisely the same direction and in a straight line (thereby passing to the south-west of Neatmoor Hall Farm House) for a distance of forty-eight chains or thereabouts to a point in the middle of the road called London Lode, and extending thence northward in a straight line (thereby crossing the roads called Middle Drove and Squire's Drove and the drain called Popham's Eau) for a distance of one mile and fifty-seven chains or thereabouts to the centre of Pingle Bridge which carries the road called Pingle Drove across the Middle Level Drain, and extending thence north-eastward along the middle of the Middle Level Drain (thereby crossing the boundary which divides the said parish of Upwell Saint Peter from the said parish of Outwell) for a distance of one mile and thirty chains or thereabouts to the centre of Angle Bridge which carries the road leading from Outwell past the Crooked Chimney Inn towards Widder's Farm across the Middle Level Drain, at which point the said imaginary line commenced."

And whereas the said church of the Holy Trinity, Nordelph, was built in pursuance of a Local Act of Parliament passed in the ninth and tenth years of Her said late Majesty and intituled "An Act for the division of the rectory of Upwell cum Welney in the county of Norfolk and in the Isle of Ely in the county of Cambridge" and the same Act is now in force.

And whereas in order that notwithstanding the existence of the said Local Act the said parish of Upwell Saint Peter might be brought within the provisions of the Church Building Acts touching the formation thereout of a parish or district, a representation such as is contemplated by the twenty-first section of the said Act of the fourteenth and fifteenth years of Her said late Majesty, chapter ninety-four, has been made to the said Ecclesiastical Commissioners by the patron and the rector or Incumbent of the rectory of the said parish of Upwell Saint Peter and by the Vestry of the same parish that it would be for the spiritual benefit of such parish that it should be brought within the provisions of the said Church Building Acts.

And whereas the said first hereinbeforementioned representation has been approved by His Majesty in Council: now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Norwich.
