

11th instant no fresh cases of cholera or deaths from that malady have occurred in the Netherlands.

In view of this fact and of the rigorous isolation and other measures of precaution which have been taken by the authorities, the Netherlands Government are of opinion that preventive measures in other countries are no longer necessary.
