Now therefore, in pursuance of the powers given to Us in that behalf, We do, by this Our Order, make the following Regulations:-

ARTICLE I.—The provisions of sub-section (1) of section 9 of the Act with respect to the driving of a motor car at a speed not exceeding ten miles per hour shall apply and have effect within the limits comprising the roads and parts of roads within the said Borough which are specified in the Schedule hereto.

ARTICLE II.—These regulations shall come into operation on the eighteenth day of October, one thousand nine hundred and nine.

SCHEDULE.

So much of Kew-road as extends from its junction with Saint John's-grove to the Quadrant, the Quadrant, George-street, Hill-street, and so much of Petersham-road as extends from its junction with Hill Rise to its junction with the

road known as Compass Hill;
So much of Petersham-road as extends from the "Dysart Arms" Public-house to the "Fox and Duck" Public-house;

Hill Rise and Richmond Hill, otherwise the Terrace; and

Lower George-street and so much of Sheenroad as extends from its junction with Lower George-street to its junction with Alton-road.

MOTOR CAR ACT, 1903.

County of East Sussex.

Whereas by sub-section 1 of section 9 of the Motor Car Act, 1903, it is enacted that within any limits or place referred to in regulations made by the Local Government Board with a view to the safety of the public, on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour:

And whereas the County Council of East Sussex have made application to the Local Government Board for a regulation to be made in pursuance of the said sub-section putting the above-mentioned provisions of that sub-section in force within the limits comprising so much of the main road from London to Lewes, within the urban district of East Grinstead, as extends from a point 30 yards west of its junction with Windmill-lane to a point 30 yards beyond the point at which that main road crosses for the second time the Tunbridge Wells and Three Bridges Line of the London, Brighton and South Coast Railway;

And whereas notice of the said application and of the time and manner in which objections should be made to any such regulation appeared in the Loudon Gazette of the 8th day of June, 1909, and in the "Sussex Daily News" of the 9th day of June, 1909, and in the "East Grinstead Observer" of the 12th day of June, 1909;
