ORDER OF THE REGISTRAR-GENERAL IN ENGLAND.

(Dated October 18th, 1909.)

Whereas by the 21st section of the Births and Deaths Registration Act, 1874, it is enacted that the Registrar-General, with the sanction of the Local Government Board, may from time to time alter Registration Sub-Districts:—

1. And whereas it is expedient (a) that St. Paul and St. Peter Wards of Blackburn County Borough should be transferred from Blackburn Northern Sub-District of Blackburn Registration District to Blackburn Western Sub-District of the same Registration District; and (b) that Blackburn Western and Blackburn Southern Sub-Districts should be re-named Blackburn South-Western and Blackburn South-Eastern respectively.

2. Now, therefore, I, Bernard Mallet, Registrar-General of Births, Deaths, and Marriages in England, in exercise of the powers given me by the above mentioned Act, and with the sanction of the Local Government Board, do hereby order and declare that the foregoing alteration shall take effect accordingly.

3. This Order shall come into operation on 1st day of November, nineteen hundred and nine.
