Section ninety-four, sub-section (4).

" or for any boat or vessel, or for any boatman or person assisting in the charge or navigation of a boat or vessel, where the boat, vessel, boatman, or person is registered or licensed by any conservators, company, body, or authority having powers, for the purpose of any such registration or licensing, under an enactment, or in pursuance of any bye-law made under an enactment (other than an enactment in the Public Health Acts, 1875 to 1907) which has effect, for the said purpose, within limits comprising waters in or adjoining the district, or waters at a distance not exceeding five miles from the nearest point in the boundary of the district."

Section ninety-four, sub-section (5).

" Nothing in this sub-section shall apply to a pleasure boat or pleasure vessel, to the owner of, or to a boatman or person assisting in the charge or navigation of, a pleasure boat or pleasure vessel, where any such pleasure boat or pleasure vessel, owner, boatman, or person is registered or licensed by any conservators, company, body, or authority having powers, for the purpose of any such registration or licensing, under an enactment, or in pursuance of any bye-law made under an enactment (other than an enactment in the Public Health Acts, 1875 to 1907) which has effect, for the said purpose, within limits comprising waters in or adjoining the district, or waters at a distance not exceeding five miles from the nearest point in the boundary of the district."

## BOROUGH OF MARGATE.

PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.

NOTICE is hereby given that an Order has been made by the Secretary of State, dated 8th October, 1909, under section 3 of the Public Health Acts Amendment Act, 1907, declaring section 78 (Regulations as to street

traffic), omitting paragraph (b), section 79 (Dangerous riding and driving), section 81 (Extending definition of public place and street for certain purposes), section 82 (Bye-laws as to seashore), and section 85 (Registries for servants) of Part VII; Part VIII (Fire Brigade), and Part IX (Sky signs) of the said Act to be in force in the Borough of Margate.

## NOTICES TO MARINERS.

(Nos. 1570 to 1581 of the year 1909.)

[The Astronomical positions are only approximate unless seconds are given. The bearings are Magnetic, and those relating to lights are given from seaward. The visibility of lights is that in clear weather. Fog signals are sounded only during thick or foggy weather unless otherwise stated. The depths given are at low-water ordinary springs. The heights given are above high water.]

## No. 1570.—NORTH SEA, GERMANY—ELBE RIVER.

*Hamburg Harbour, Tunnel Works—Temporary Leading Lights.*

Subject.—On or about the 15th October, 1908, two temporary lights of the undermentioned characters would be established on the northern side of Hamburg Harbour, Elbe River, in connection with the tunnel works in progress.

Position.—On north-western extremity of Nieder Haven Breakwater, lat. 53° 32' 45" N., long. 9° 58' 31" E., on Chart No. 3262.

Character.—A red fixed light and a green fixed light, placed horizontally, 5 feet apart.

Elevation.—15 feet.

Visibility.—Red light 4 miles, from the bearing S. 38° E. to S. 86° E.; green light 3 miles, from the bearing S. 86° E., through east to N. 56° E.

Remarks.—The boundary line between the red and green lights, S. 86° E., points out the position of the light-buoy recently established to mark the tunnel works. Should the buoy be missing or its light extinguished, by keeping in the red light vessels of heavy draught will avoid the shoal caused by the works extending from the southern side of the river.

## No. 1571.—EASTERN ARCHIPELAGO—CELEBES, EAST COAST.

*Buton Island—Reef Eastward of Matarani Bay—Reefs.*

Subject.—The undermentioned reefs, not hitherto shown on the charts, exist off the south-east coast of Celebes.

1. Eastward of Buton Island:

Position.—Lat. 4° 38' S., long. 123° 14' E.  
Depth.—Not ascertained.
