ORDER of the Local Government Board: Motor Car Act, 1903: Regulations under Section 9 (1).

COUNTY OF MIDDLESEX.

Urban District of Teddington.

To the County Council of Middlesex;-

And to all others whom it may concern.

Whereas by sub-section (1) of section 9 of the Motor Car Act, 1903 (hereinafter referred to as "the Act"), it is enacted that, within any limits or place referred to in Regulations made by Us, the Local Government Board, with a view to the safety of the public, on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour:

And whereas the County Council of Middlesex, having made application to Us to make a Regulation in pursuance of the said sub-section putting the above-mentioned provisions of that sub-section in force within the limits comprising a certain road situate within the urban district of Teddington, We directed a Local Inquiry to be held into the matter by one of Our Inspectors, and the Inquiry was held accordingly, and Report has been made to Us thereon:

. Now therefore, in pursuance of the powers given to Us in that behalf, We do, by this Our Order, make the following Regulations:—

ARTICLE I.—The provisions of sub-section (1) of section 9 of the Act with respect to the driving of a motor car at a speed not exceeding ten miles per hour shall apply and have effect within the limits comprising so much of Waldegrave-road, within the urban district of Teddington, as extends from its junction with Highstreet to its junction with Teddington Park (formerly Blenheim-road).

ARTICLE II.—These Regulations shall come into operation on the twenty-second day of November, one thousand nine hundred and nine.

\*ORDER OF THE REGISTRAR-GENERAL IN ENGLAND.

(Dated November 18th, 1909.)

Whereas by the 21st section of the Births and Deaths Registration Act, 1874, it is enacted that the Registrar-General, with the sanction of the

Local Government Board, may from time to time alter Registration Sub-Districts:—

1. And whereas it is expedient in order that Stourbridge and Kings Norton Registration Districts may be made co-extensive with the Poor Law Unions of the same names, as altered by the Local Government Board's Provisional Order, No. P. 2182, which was confirmed by the Local Government Board's Provisional Orders Confirmation (No. 7) Act, 1909, and took effect on the 9th November, 1909, that Quinton Civil Parish should be transferred from Halesowen Sub-district of Stourbridge Registration District to Edgbas on Sub-district of Kings Norton Registration District;

2. Now, therefore, I, Bernard Mallet, Registrar-General of Births, Deaths, and Marriages in England, in exercise of the powers given me by the above mentioned Act, and with the sanction of the Local Government Board, do hereby order and declare that the foregoing alteration shall

take effect accordingly.

3. This Order shall come into operation on 1st day of December, nineteen hundred and nine.

FARNWORTH URBAN DISTRICT COUNCIL.

THE PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.

Government Board have by an Order dated the 11th day of November, 1909, declared, specified and directed that sections 18, 19, 20, 21, 22, 24, 26, 27, 28, 29, 30, 31 and 32 comprised in Part II (Streets and buildings); sections 31, 35, 36, 37, 38, 43, 44, 46, 48, 49, 50 and 51 comprised in Part III (Sanitary provisions); sections 52, 54, 55, 50, 57, 58, 59, 60, 61, 62, 63, 64, 65, 66, 67 and 68 comprised in Part IV (Infectious diseases); Part V (Common lodging-houses); Part VI (Recreation grounds); and section 95 comprised in Part X (Miscellaneous); shall be in force in the urban district of Farnworth, subject as regards section 27 (Part II), sections 35 and 38 (Part III). section 59 (Part IV) and section 75 (Part V) to certain conditions and adaptations set forth in the first schedule to the said Order.

Sections 18, 19, 20, 21, 22, 24, 25, 27, 28, 29, 30, 31 and 32 shall have effect subject in each case to the operation of section 33, and as if, so far as the circumstances require, that section were incorporated with and formed part of each of the said sections.

Schedule III of the Order repeals section 52 of the "Farnworth Park and Improvement Act, 1867," so far as the section relates to any subject matter of section 44 of the Act of 1907, and section 67 of the "Farnworth Urban Dis rict Council Act, 1900," so far as the section relates to any subject matter of section 32 of the Act of 1907.

And the Board further declare that the said ()rder shall come into operation on the 30th day of December, 1909.
