of Hanley Child, the tithe rentcharge on the glebe land, apportioned at three pounds nine

shillings, having been merged.

"The whole of the extraordinary (hop) tithe rentcharge arising on lands in the parish of Hanley William (redeemed at two pounds eight shillings and ninepence).

"The whole of the extraordinary (hop) tithe rentcharge arising on lands in the parish of Hanley Child (redeemed at three pounds two

shillings and sixpence).

"Nine acres three roods and twenty-four perches of glebe land in the parish of Hanley Child, Numbers 148, 149, 150 and 152 on the plan hereunto annexed, now let to W. Harris.

"Two acres three roods and three perches of glebe land in the parish of Hanley Child number part 314 and part 317 on the plan hereunto annexed, now let to J. H. Bone.

"The tithe rentcharge (apportioned at twenty-eight pounds ten shillings) arising on the Fulham's Farm, being a detached portion of the parish of Eastham and on lands covered by Modus set out at the end of the tithe apportionment for the parish of Eastham and numbered 1 to 20 (inclusive) and from 23 to 54 both inclusive on the plan A attached to such tithe apportionment.

"The whole of the extraordinary (hop) tithe rentcharge arising on the before-mentioned Fulham's Farm, in the detached portion of the parish of Eastham (redeemed at one pound

fourteen shillings and fivepence).

"That baptisms, churchings, marriages and burials shall as heretofore be performed in the churches of the benefice so to be constituted, and that the fees for all such offices performed within the limits of the said benefice and all ecclesiastical dues, offerings and other emoluments arising from or in respect of the said benefice and usually paid to the incumbent of a benefice shall belong to the Incumbent of the said intended perpetual curacy or benefice of Hanley William with Hanley Child.

"That the patronage or right of nominating a Minister to the church of such perpetual curacy and benefice shall be for ever vested in and be exercised by the said Reverend Ernest Edward Lea, the present Patron, and his heirs, executors,

administrators or assigns for ever.

"That the inhabitants of the said chapelries of Hanley William and Hanley Child shall be exonerated from all liability to repair the parish church of Eastham and from all rates, charges and assessments (if any) to be made for or in respect of the same or any other church or chapel now or hereafter to be erected in the said parish but shall be exclusively liable to the repairs respectively of the churches at Hanley William and Hanley Child.

"That the first fruits, thirty-four pounds three shillings and ninepence, and tenths, three pounds eight shillings and fourpence, now charged upon the rectory of Eastham, shall be apportioned as follows: -- The Rectory of Eastham is to be subject to twenty-three pounds eight shillings and fivepence first fruits, and two pounds six shillings and tenpence tenths, and the perpetual curacy of Hanley William with Hanley Child to ten pounds fifteen shillings and fourpence first fruits, and one pound one shilling and sixpence tenths.

"That the parishioners of the said proposed separate parish shall not hereafter be entitled to accommodation in the church of Eastham, nor shall the parishioners of Eastham be entitled to any accommodation in the churches of Hanley

William or Hanley Child."

And whereas the Reverend Ernest Edward Lea, as Patron and Incumbent of the said rectory of Eastham, has signed the consent following :-

"CONSENT.

"I, the Reverend Ernest Edward Lea the Patron or the person entitled to present to the rectory of Eastham, in the county of Worcester and diocese of Hereford, in case the same were now vacant, and being also the Rector of the same rectory, do hereby signify to your Grace my consent to the scheme above proposed for separating the chapelries of Hanley William and Hanley Child from the said parish of Eastham, and for constituting the said two chapelries into a separate benefice and a perpetual curacy.

"Ernest Edward Lea."

And whereas the said scheme hath been transmitted by the said Bishop to the said Archbishop for his consideration:

And whereas the said Archbishop being satisfied with the said scheme hath certified the same and the consent aforesaid to His Majesty in Council by his report dated the thirteenth day of July, one thousand nine hundred and nine, which said report is in the words and figures following:

"We the undersigned Randall Thomas, Archbishop of the province of Canterbury, do hereby

report to Your Majesty in Council-

"That the Right Reverend John, Lord Bishop of Hereford, has represented unto us (amongst other things):

"That there is in the county of Worcester and his diocese of Hereford, the rectory of Eastham with the chapelries of Hanley William, Hanley Child, and Orleton annexed.

"That the population of the said chapelry of Hanley William is one hundred and one, and the population of Hanley Child is one hundred and eighty-eight, for which there is sufficient accommodation at the respective churches.

"That a parsonage house has been erected in the parish of Hanley Child, situate midway between the churches of Hanley William and Hanley Child, which churches are two miles

apart.

"That it appears to the said Lord Bishop that the said chapelries of Hanley William and Hanley Child may, under the provisions of the Pluralities Act, 1838, and the Church Building Act, 1839, be advantageously separated from the said parish of Eastham and be constituted a separate parish and perpetual curacy for ecclesiastical purposes only.

"That pursuant to the directions contained in the twenty-sixth section of the said first mentioned Act of Parliament the said Lord Bishop has drawn up a scheme in writing describing the mode in which it appears to him that the alteration above proposed may be best effected and how the changes consequent on such alteration in respect to ecclesiastical jurisdiction, glebe lands, tithe rentcharge and other ecclesiastical dues rates and payments and in respect to patronage and rights to pews may be made with justice to all parties interested, which scheme together with the con-sent thereto in writing of the Reverend Ernest Edward Lea the Patron or person entitled to present to the said rectory of Eastham in case the same were now vacant and also as the Rector of the same rectory, has been transmitted to us for our consideration.

"The representation and scheme of the said Lord Bishop and the consent before referred to

are hereunto annexed.
