ORDER of the Local Government Board: Altering General Consolidated Order: Daily Visitation of Sick and Lying-in Wards of Workhouse: Transferring certain Duties from Master and Matron to Superintendent Nurse:—

BAKEWELL UNION.

To the Guardians of the Poor of the Bakewell Union ;---

And to all others whom it may concern.

Whereas by a General Order dated the 24th day of July, 1847, the Poor Law Commissioners made certain Rules and Regulations with regard to the government of the Workhouses of certain Unions, including the Bakewell Union, and the duties of persons appointed to certain offices in the said Workhouses, including the offices of Master and Matron of the Workhouse;

And whereas by Articles 208 and 210 of the said Order the Master and Matron of the Workhouse are respectively required to visit the wards of the male and female paupers every morning and night, and to see that the regulations prescribed in the said Articles are duly and properly carried out;

And whereas it is expedient that other provision should be made as regards the visitation of the sick and lying-in wards of the Workhouse of the said Union:

Now therefore, We, the Local Government Board, in pursuance of the powers given to Us by the Statutes in that behalf, hereby Order that the following Regulations shall be in force in the said Bakewell Union as regards the visitation of the sick and lying-in wards of the Workhouse of the Union :—

ARTICLE I.—It shall be the duty of the Superintendent Nurse to visit each of the sick and lying-in wards of the Workhouse daily and to see that the said wards have been duly cleansed and are properly warmed and ventilated, and also that all such arrangements are made as may be necessary for the proper care of and attendance upon the sinmates both by day and during the night.

day and during the night. ARTICLE II.—The duty of making morning and nightly visits to the sick and lying-in wards of the Workhouse shall cease to be part of the duties of the Master or Matron of the Workhouse, as the case may be; but, except to this extent, nothing in this Order shall affect the duties of the Master or Matron so far as those duties relate to the general control of the Workhouse.

MOTOR CAR ACT, 1903.

County of East Sussex.

Whereas by sub-section 1 of section 9 of the Motor Car Act, 1903, it is enacted that within any limits or place referred to in regulations made by the Local Government Board with a view to the safety of the public, on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour:

Notice is hereby given that the County Council of East Sussex have made application to the Local Government Board for a regulation to be made in pursuance of the said sub-section putting the above-mentioned provisions of that subsection in force within the limits comprising the following roads or parts of roads within the parish of Rottingdean, that is to say:—

So much of the main road from Brighton to Newhaven as extends from a point situate 50 yards to the west of the western side of Waltham House to the western side of the public footpath at the rear of the premises on the east side of High-street.

High-street, from a point in line with the post and chain fence on the south side of the approach road leading to the house known as "Challoners" to the top of the approach road leading to the seashore.

Church-road, from its junction with High-street near "Challoners" to its junction with Highstreet at the house known as "The Chalet" opposite the Fire Station.

West-street, from its junction with High-street to its junction with the main road abovementioned.

ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 30TH DECEMBER 1909.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1909, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Power to serve Notices as regards certain Sheep.

1.—(1.) An Inspector of the Local Authority or of the Board of Agriculture and Fisheries may serve on the owner or person in charge of any sheep on the premises in the occupation of Mr. Herbert O. Pugh, of Cymmerau, Glandyfi, in the county of Cardigan, or of any sheep which have, on or since the first day of September last, been moved from such premises, or of any sheep which have been in contact with any such sheep, a Notice prohibiting movement of the sheep from the premises where the sheep are at the time of service of the Notice until the Notice is withdrawn, and requiring that such sheep shall, within six weeks from the date of this Order, be thoroughly dipped twice, in the presence and to the satisfaction of an Inspector of the Local Authority, in a sheep-dip approved by the Board of Agriculture and Fisheries, or purporting to be so approved.

(2.) Each dipping shall be carried out on such date, not earlier than ten days after a previous dipping, at such dipping place and in such manner as shall be required by an Inspector of the Local Authority.

(3.) A Notice served under this Order may be withdrawn by an Inspector of the Board by written notice to that effect.

Offences.

2. If any sheep are moved in contravention of any Notice served under this Order, or are not dipped in accordance with the requirements of this Order, the owner or person in charge of the sheep shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Diseases of Animals Act, 1894.

Declaring certain Sections comprised in Parts II, III, IV, and X of the Public Health Acts Amendment Act, 1907, to be in force.

HUNSLET RURAL DISTRICT.

To the Rural District Council of Hunslet;-And to all others whom it may concern.

WHEREAS the Rural District Council of Ilunslet (hereinafter referred to as "the Local Authority") have, in pursuance of section 3 of the Public Health Acts Amendment Act, 1907. (hereinafter referred to as "the Act of 1907"), applied to us, the Local Government Board, to declare certain sections of the Act of 1907 to be in force in the several contributory places within the Rural District of Hunslet (hereinafter referred "to as "the District");

And whereas proof has been given to our satisfaction of the advertisement required by sub-section (2) of section 3 of the Act of 1907, and at least one month has elapsed after the date of that advertisement:

Now therefore, in the exercise of our powers in that behalf, we by this Order declare, specify, and direct as follows; that is to say:—

Article I.—(1) On and after the day on which this Order comes into operation,—

Sections 15, 16, 17, 18, 20, 21, 22, 23, 24, 25, 27, 28, 29, 30, 31, 32 and 33 comprised in Part II;

Sections 34, 35, 38, 39, 40, 41, 42, 43, 44, 45, 46. 49 and 51 comprised in Part III;

Sections 52, 53, 54, 55, 56, 57, 58, 59, 61, 62, 64, 65, 66 and 67 comprised in Part IV; and

Section 95 comprised in Part X

of the Act of 1907 shall be in force in the several contributory places within the District.

(2) Where a section to which reference is made in the first column of the schedule to this Order is one of the sections by subdivision (1) of this article described as comprised in Part II, Part III. or Part IV, and declared to be in force, the section shall be in force in each of the contributory places within the District, subject to the following conditions and adaptations; that is to say,—

Unless and until We, by a further Order made on such application and after compliance with such requirements as are described and set forth in section 3 of the Act of 1907, otherwise declare, specify, and direct, the said section in its application to the contributory place and in relation to the exercise of the powers and to the discharge of the duties of the Local Authority under that section, shall have effect as if the words and figures set forth in the second column of the said schedule opposite to the reference to that section in the first column of that schedule were added to and formed part of the section.

Article II.—Within the period of three weeks immediately following the date of this Order, or, where in Our opinion the circumstances so require, within such later period as We by Order prescribe, the Local Authority shall cause this Order to be published by advertising the same once at least in one or more of the newspapers circulating in the District, and shall also cause a statement of the effect of this Order to be published in the London Gazette.

ARTICLE III.—This Order shall come into operation on the thirty-first day of January, one thousand nine hundred and ten.

SCHEDULE.

Parts and Sections. Conditions and Adaptations.

2. 1. PART II. "The power of making or Section twentyfive. enforcing bye-laws under section one hundred and fifty-seven of the Public Health Act, 1875, as extended by section twentythree of the Public Health Acts Amendment Act, 1890, with respect to the paving of yards and open spaces in connection with dwelling - houses, shall cease to be exercisable." "(7) Nothing in this section Section twentyseven: shall apply to any temporary building erected or set up for use by the Territorial Force." PART III.
