#### WILD BIRD (ENGLAND).

The Wild Birds Protection (Administrative County of Westmorland) Order, 1910.

Dated 5th January, 1910.

In pursuance of the powers conferred on me by the Wild Birds Protection Acts, 1880 to 1908, and upon application by the Council of the Administrative County of Westmorland, I hereby make the following Order:—

##### *Title.*

I. This Order may be cited as "The Wild Birds Protection (Administrative County of Westmorland) Order, 1910."

*Certain Eggs protected throughout the County.*

II. The taking or destroying of the eggs of the following species of Wild Birds is prohibited throughout the Administrative County of Westmorland for a period of three years from the date of this Order:—

Bittern, Common Buzzard, Dipper or Water Ouzel, Dotterel, Peregrine Falcon, Goldfinch, Lesser Black-backed Gull, Hawfinch, Heron, Kestrel, Kingfisher, Merlin, Nightjar (Goat Sucker, Night Hawk or Fern Owl), Barn Owl, Brown or Wood Owl, Long-eared Owl, Short-eared Owl, Golden Plover, Green Plover (Lapwing or Peewit), Raven, Redshank, Sheldrake, Snipe, Woodcock and Wryneck (Cuckoo's Mate or Snake Bird).
