"Now, therefore, with the consent of the said Herbert Lloyd Watkin Williams Wynn being the person whose consent as Patron is required by the provisions of the hereinbefore mentioned Acts and of the Act of the first and second years of Her said late Majesty, chapter one hundred and six (in testimony of which consent he has signed and sealed this scheme), and with the consent of the said Watkin Herbert, Bishop of Bangor (in testimony whereof he has signed this scheme and sealed the same with his episcopal seal), and with the consent of the persons to whom together with the said Herbert Lloyd Watkin Williams Wynn and the said Watkin Herbert, Bishop of Bangor, it is hereinafter recommended and proposed that the said advowson or perpetual right of patronage shall be transferred, that is to say, with the consent of Robert Watkin Williams Wynn, of Dolben, in the county of Flint, Esquire, Arthur Watkin Williams Wynn, of Coedymaen, in the county of Montgomery, Esquire, and Watkin Randle Kynaston Mainwaring of Hartsheath, near Mold, in the county of Flint, Esquire (in testimony whereof they have signed and sealed this scheme), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole advowson or perpetual right of patronage of and presentation to the said benefice of Carno shall be transferred to the said Herbert Lloyd Watkin Williams Wynn, Watkin Herbert, Bishop of Bangor, Robert Watkin Williams Wynn, Arthur Watkin Williams Wynn, and Watkin Randle Kynaston Mainwaring, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Herbert Lloyd Watkin Williams Wynn, Watkin Herbert, Bishop of Bangor, Robert Watkin Williams Wynn, Arthur Watkin Williams Wynn, and Watkin Randle Kynaston Mainwaring their heirs and assigns for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any

other Act of Parliament.

And whereas the said scheme has been approved

by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts: and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Bangor.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the thirty-third and thirty-fourth years of Her late Majesty Queen Victoria, chapter thirty-

nine, and of the Acts therein mentioned, that is to say, the Act of the third and fourth years of Her said late Majesty, chapter one hundred and thirteen, the Act of the fourth and fifth years of Her said late Majesty, chapter thirty-nine, and the Act of the thirty-first and thirty-second years of Her said late Majesty, chapter one hundred and fourteen, duly prepared and laid before His Majesty in Council a scheme bearing date the fourth day of November, in the year one thousand nine hundred and nine, in the words following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the thirtythird and thirty-fourth years of Her late Majesty Queen Victoria, chapter thirty-nine, and of the Acts therein mentioned, that is to say, the Act of the third and fourth years of Her said late Majesty, chapter one hundred and thirteen, the Act of the fourth and fifth years of Her said late Majesty, chapter thirty-nine, and the Act of the thirty-first and thirty-second years of Her said late Majesty, chapter one hundred and fourteen, have prepared and now humbly lay before Your Majesty in Council the following scheme for effecting a transfer of the ownership of the advowson or perpetual right of patronage of and presentation to the church and cure (hereinafter called 'the said benefice') of Finstock-cum-Fawler, in the county of Oxford and in the diocese of Oxford.

"Whereas the advowson or perpetual right of patronage of and presentation to the said benefice of Finstock-cum-Fawler is vested for an estate in fee simple in possession free from incumbrances in the President and Scholars of Saint John Baptist College, in the University of Oxford (hereinafter called 'the present Patrons').

" And whereas the present Patrons are desirous that the whole advowson or perpetual right of patronage of and presentation to the said benefice of Finstock - cum - Fawler now vested in them as aforesaid should be transferred to and be vested in the Reverend Julius Delmege Payne, as Vicar or Incumbent for the time being of the vicarage of Charlbury, in the said county and diocese of Oxford, and his successors, Vicars or Incumbents of the said vicarage of Charlbury for

"And whereas the Right Reverend Francis, now Bishop of Oxford, in token that the same transfer has that consent of the Bishop of the diocese, which by the Acts in the hereinbefore mentioned Act recited, or by some or one of them, is made necessary, has executed this

scheme as hereinafter mentioned.

"And whereas the transfer of the patronage of the said benefice of Finstock-cum-Fawler, which is hereinbefore mentioned and hereinafter recommended and proposed, will render the same benefice more eligible for augmentation out of funds under our control, and this circumstance will, in our opinion, tend to make better provision for the cure of souls in the parish or district in or in respect of which the right of patronage or advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the particular district or new parish of Finstock-cum-Fawler.
