- "(3) The maximum pension for a Chief Schoolmaster to be £150 a year instead of £120 as fixed by Order in Council of twenty-ninth February, one thousand nine hundred and eight.
- "(4) Head Schoolmasters to be pensioned on the scale of pension applicable to Naval Schoolmasters in such cases as may be for their advantage, service as Head Schoolmaster being allowed to reckon as superior Petty time.
- "(5) The scale of pensions for widows and compassionate allowances to legitimate children of Chief Schoolmasters and Head Schoolmasters to be as follows, viz.:—

- "(a) The conditions of one year's seniority and one year's service in the above scale not to be applicable in cases where the special rates are payable.
- "(b) In the event of a Chief Schoolmaster of three years' seniority dying while on the Active List after attaining the age for optional retirement, his widow and children to be eligible, at the discretion of the Admiralty, for pension and Compassionate Allowances on the scale applicable to Junior Lieutenants.
- "(c) In the case of a Chief Schoolmaster retired with the relative rank of Lieutenant, the rates to be the same as for Junior Lieutenants.
