to the Schedule by Clause III of this Order, is prohibited within the Administrative County of the West Riding of Yorkshire:-

Blackcap, Black-headed Bunting, Cirl Bunting, Corn Bunting, Reed Bunting, Common Buzzard, Honey Buzzard, Chiffchaff, Dipper, Falcon, Pied Flycatcher, Spotted Flycatcher, Heron, Hobby, Kestrel, Landrail or Corn Crake, Linnet, House Martin, Sand Martin, Merlin, Nuthatch, Peregrine Falcon, Meadow Pipit, Rock Pipit, Tree Pipit, Raven, Lesser Redpole, Redstart, Ring Ouzel, Shrike (Butcher Bird), Stonechat, Swallow, Swift, Bearded Tit (Reedling or Reed Pheasant), Coal Tit, Long-tailed Tit, Marsh Tit, Treecreeper, Turtle Dove, Grey Wagtail, White Wagtail, Yellow Wagtail, Dartford White Wagtail, Yellow Wagtail, Dartford Warbler, Garden Warbler, Grasshopper Warbler, Reed Warbler, Sedge Warbler, Willow Warbler, Wood Warbler, Water Rail, Wheatear, Whinchat, Whitethroat, Lesser Whitethroat, Common Wren, Fire-crested Wren, Golden-crested Wren, Wryneck (Cuckoo's Mate or Snakebird).

The taking or destroying of the eggs of the Lapwing, Peewit, or Green Plover is prohibited after April 14th in each year.

now considered free from Cholera.
