## PRESENT,

The KING's Most Excellent Majesty in Council.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the thirty-third and thirty-fourth years of Her late Majesty Queen Victoria, chapter thirty-nine, and of the Acts therein mentioned, that is to say, the Act of the third and fourth years of Her said late Majesty, chapter one hundred and thirteen, the Act of the fourth and fifth years of Her said late Majesty, chapter thirty-nine, and the Act of the thirty-first and thirty-second years of Her said late Majesty, chapter one hundred and fourteen, duly prepared and laid before His Majesty in Council a scheme bearing date the fourth day of November, in the year one thousand nine hundred and nine, in the words following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the thirty-third and thirty-fourth years of Her late Majesty Queen Victoria, chapter thirty-nine, and of the Acts therein mentioned, that is to say, the Act of the third and fourth years of Her said late Majesty, chapter one hundred and thirteen, the Act of the fourth and fifth years of Her said late Majesty, chapter thirty-nine, and the Act of the thirty-first and thirty-second years of Her said late Majesty, chapter one hundred and fourteen, have prepared and now humbly lay before Your Majesty in Council the following scheme for effecting a transfer of the ownership of the advowson or perpetual right of patronage of and

presentation to the church and cure (hereinafter called 'the said benefice') of Saint Hilda, Sherburn, in the county of York and in the diocese of York.

"Whereas by virtue of the will of the late Sir George Cholmley, Baronet, and of a conveyance made the fourth day of January in the year one thousand eight hundred and seventy-five by Walter William Strickland, E-quire, to Sir Charles William Strickland of Boynton, Bridlington, in the county of York. Baronet, the advowson or perpetual right of patronage of and presentation to the said benefice of Saint Hidd, Sherburn, is now subject to a term of years created by the same will for securing family charges vested in the said Sir Charles William Strickland, during his life, and the said Charles William Strickland is therefore the Patron or person entitled to present or nominate to the said benefice in case the same were now vacant.

"And whereas the said Charles William Strickland is desirous that the whole advowson or perpetual right of patronage of and presentation to the said benefice of Saint Hilda, Sherburn, should be transferred to the Dean and Chapter of the Cathedral and Metropolitical Church of Saint Peter at York (hereinafter called the said Dean and Chapter) and their successors.
