the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole undivided moiety of the advowson or perpetual right of patronage of and presentation to the said benefice of Saint Peter with Saint Mary, Ampney, now vested in him, the said Edward Kaye Daubeney as aforesaid, shall be transferred to the said Edgar Charles Sumner, Bishop of Gloucester, and his successors in the same Bishoprick, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Edgar Charles Sumner, Bishop of Gloucester, and by his successors in the same Bishoprick for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament.

And whereas the said scheme has been approved

by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts: and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Gloucester.

## PRESENT.

The KING's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the thirty-third and thirty-fourth years of Her late Majesty Queen Victoria, chapter thirty-nine, and of the Acts therein mentioned, that is to say, the Act of the third and fourth years of Her said late Majesty, chapter one hundred and thirteen, the Act of the fourth and fifth years of Her said late Majesty, chapter thirty-nine, and the Act of the thirty-first and thirty-second years of Her said late Majesty, chapter one hundred and fourteen, duly prepared and laid before His Majesty in Council a scheme bearing date the second day of December, in the year one thousand nine hundred and nine, in the words and figures following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the thirtythird and thirty-fourth years of Her late Majesty Queen Victoria, chapter thirty-nine, and of the Acts therein mentioned, that is to say, the Act of the third and fourth years of Her said late Majesty, chapter one hundred and thirteen, the Act of the fourth and fifth years of Her said late Majesty, chapter thirty-nine, and the Act of the thirty-first and thirty-second years of Her said late Majesty, chapter one hundred and fourteen, have prepared and now humbly lay before Your Majesty in Council the following scheme for effecting a transfer of the in the London Gazette of any Order of Your

ownership of each of the advowsons or perpetual right of patronage of and presentation to the church and cure (hereinafter called 'the said benefice') of the Lodge, in the county of Salop and in the diocese of Saint Asaph, and the church and cure (hereinafter called 'the said benefice') of Llansantffraid Glyn Ceiriog, in the county of Denbigh and in the said diocese of Saint Asaph.

"Whereas the advowson or perpetual right of patronage of and presentation to the said benefice of the Lodge and the advowson or perpetual right of patronage of and presentation to the said benefice of Llansantffraid Glyn Ceiriog are vested for an estate in fee simple free from incumbrances in certain Trustees upon trust in the first place for Arthur William, Baron Trevor (hereinafter called the said Lord Trevor) of Brynkinalt, Chirk, in the county of Denbigh, during his life, and the said Lord Trevor is therefore the Patron or person entitled to present or nominate to the said benefices respectively in case the same were now vacant.

"And whereas the said Lord Trevor is desirous that the whole advowson or perpetual right of patronage of and presentation to the said benefice of the Lodge and the whole advowson or perpetual right of patronage of and presentation to the said benefice of Llansantffraid Glyn Ceiriog should be transferred in the manuer which is hereinafter recommended and proposed.

"And whereas the Right Reverend Alfred George, now Bishop of Saint Asaph, in token that the same transfer has that consent of the Bishop of the diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary, has executed

this scheme as hereinafter mentioned. "And whereas the transfer of the patronage of the said benefice of the Lodge and of the said benefice of Llansantffraid Glyn Ceiriog which is hereinbefore mentioned and hereinafter recommended and proposed will render the same benefices more eligible for augmentation out of funds under our control, and this circumstance will in our opinion tend to make better provision for the cure of souls in the parishes or districts in or in respect of which the rights of patronage or advowsons so recommended and proposed to be transferred as aforesaid respectively arise or exist, that is to say, in the new parish of the Lodge and in the parish of Llansantffraid Glyn

"Now, therefore, with the consent of the said Lord Trevor, being the person whose consent as Patron is required by the provisions of the hereinbefore mentioned Acts, and of the Act of the first and second years of Her said late Majesty, chapter one hundred and six (in testimony of which consent he has signed and sealed this scheme), and with the consent of the said Alfred George, Bishop of Saint Asaph (in testimony whereof he has signed this scheme and sealed the same with his episcopal seal), and with the consent of the persons to whom together with the said Lord Trevor it is hereinafter recommended and proposed that the said advowsons or perpetual right of patronage shall be transferred, that is to say, with the consent of George Ralph Charles, Baron Harlech (hereinafter called 'the said Lord Harlech'), of Brogyntyn, Oswestry, in the county of Salop, and James Darlington, of Black Park, Chirk, in the county of Denbigh, Esquire (in testimony whereof they have signed and sealed this scheme), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication
