prevent us from representing, recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the hereinb-fore mentioned Acts or of any of them or of any other Act of Parliament.

"The SCHEDULE to which the foregoing Scheme or Representation has reference.

"The territory to be annexed to the new parish of Wall, in the county of Stafford and in the diocese of Lichfield, being :----

"I. All that portion of the new parish of Ogley Hay, in the said county and diocese, which is bounded upon the east partly by the new parish of Stomail, partly by the parish of Shen-tone, both in the said county and diocese, and partly by the said new parish of Wall, upon the north by the new parish of Saint John the Baptist, Hammerwich, in the said county and diocese, and upon the remaining sides, that is to say, upon the north-west and upon the south-west, by an imaginary line commencing upon the boundary which divides the said new parish of Saint John the Baptist, Hammerwich, from the said new parish of Ogley Hay at a point in the middle of the road leading from Lichfield to Newport, opposite to the northern end of the wall or fence forming the western boundary of the houses and premises known as the Cottages, and extending thence southward to and along the said wall or fence for a distance of four chains and a half or thereabouts to the point where such wall or fence meets the fence forming the north-western boundary of the close numbered 1 upon the map or plan which is annexed to this scheme or representation, and extending thence south-westward along the said fence and along the fences forming the north-western boundaries of the closes numbered 2, 3, and 4 upon the said map or plan for a distance of twenty-two chains and a half or thereabouts to the point where the fence forming the north-western boundary of the said close numbered 4 meets the north-eastern side of the Wyrley and Essington Canal, and extending thence first south westward to and then first south-eastward and then eastward along the middle of the said canal for a distance of thirteen chains or thereabouts to the centre of the bridge which carries the road leading from Walsall to Lichfield across such canal, and extending thence south-eastward in a straight line for a distance of thirty-seven chains and a half or thereabouts to the point in the middle of Cranebrook-lane where the boundary which divides the said new parish of Ogley Hay from the said new parish of Stonnall diverges from the said lane.

"II. Also all that portion of the said parish of Sheustone which is bounded upon the north and upon the north-west by the said new parish of Wall, upon the west by the above described portion of the said new parish of Ogley Hay, upon part of the south by the said new parish of Stonnall, and upon the remaining sides, that is to say, upon the remaining part of the south and upon the east, by an imaginary line commencing upon the boundary which divides the said new parish of Stonnall from the said parish of Shenstone at the junction of Thornynurst-lane with the roadway and footpath leading to Galey Cottage and Raikes-lane and extending thence south-eastward along the middle of the said roadway and footpath for a distance of twelve chains or thereabouts to the centre of the footbridge which carries such footpath across the Crane Brook, and extending thence generally eastward along the middle of Crane Brook for a distance of seventy-three chains or thereabouts

to the centre of the bridge which carries Raikesiane across the said brook and extending thence first north-eastward and then eastward along the middle of Raikes-lane for a distance of twentyseven chains or thereabouts to its junction with Ashcroft-lane, and extending thence in a straight line due east for a distance of thirty-eight chains or thereabouts to a point in the middle of the Sutton Coldfield to Lichfield line of the London and North Western Railway and extending thence northward along the middle of the said line of railway for a distance of thirty-five chains or thereabouts to the centre of the bridge which carries such line of railway across the road leading from Swinfen to Wall upon the boundary which divides the said parish of Shenstone from the said new parish of Wall.

"III. And also all that portion of the parish of Saint Michael, Lichfield, in the said county of Stafford and in the said diocese of Lichfield, which is bounded upon the north by the new parish of Christ Church, Lichfield, in the said county and diocese upon the west, upon the south-west, and upon the south-east by the said new parish of Wall, and upon the remaining side, that is to say, upon the east, by an imaginary line commencing upon the boundary which divides the said new parish of Wall from the said parish of Saint Michael, Lichfield, at the junction of Knowle-lane with the road leading from Birmingham to Lichfield, and extending thence northward along the middle of the last-mentioned road for a distance of sixty-seven chains or thereabouts to its junction with Fosseway-lane upon the boundary which divides the said parish of Saint Michael, Lichfield, from the said new parish of Christ Church, Lichfield."

And whereas drafts of the said scheme or representation have been transmitted to the Patrons and to the Incumbents of the cures affected by the arrangements which are contemplated by such scheme or representation and such Patrons and Incumbents have respectively signified their assent thereto.

And whereas the said scheme or representation has been approved by His Majesty in Council :

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme or representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Lichfield.
