Whereas by sub-section (1) of section 9 of the Motor Car Act, 1903 (hereinafter referred to as "the Act"), it is enacted that, within any limits or place referred to in Regulations made by Us, the Local Government Board, with a view to the safety of the public, on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour;

And whereas We have received and duly considered an application from the County Council of Essex for the issue of a Regulation in pursuance of the said sub-section putting the abovementioned provisions of that sub-section in force within the limits comprising parts of certain roads situate within the parish of Harlow, in the county of Essex:

Now therefore, in pursuance of the powers iven to Us in that behalf, We do, by this Our Order, make the following Regulations:-

ARTICLE I.—The provisions of sub-section (1) of section 9 of the Act with respect to the
