

WILD BIRD (ENGLAND).

The Wild Birds Protection (Administrative County of Cornwall) Order of 1910.

Dated 11th February, 1910.

In pursuance of the powers conferred on me by the Wild Birds Protection Acts, 1880 to 1908, and upon application by the Council of the Administrative County of Cornwall, I hereby make the following Order :—

Title.

I. This Order may be cited as "The Wild Birds Protection (Administrative County of Cornwall) Order, 1910."

BIRDS.

The Owl protected during the whole of the Year.

II. During that period of the year to which the protection afforded by the Wild Birds Protection Act, 1880, does not extend, the killing or taking of the Owl (all species) is prohibited throughout the Administrative County of Cornwall.

EGGS.

Certain Eggs protected throughout the Administrative County.

III. The taking or destroying of the eggs of the following species of Wild Birds is prohibited throughout the Administrative County of Cornwall :—

Cornish Chough, Owl (all species).

Repeal of former Order.

IV. The Order of the 12th December, 1894, is hereby repealed.

TENDERS FOR LOANS ON TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Monday, the 14th instant, at one o'clock, for Treasury Bills to be issued under the Acts 40 Vic., cap. 2, 52 Vic., cap. 6, and 9 Ed. VII, c. 5, to the amount of £3,500,000, of which £3,000,000 will be in replacement of Bills falling due on the 17th instant and £500,000 will be an additional issue.

2. The Bills will be in amounts of £1,000, £5,000, or £10,000, and will be dated the 17th February, 1910. Bills for £1,500,000 will be payable at *six months* after date, viz. :—on the 17th August, 1910, and Bills for £2,000,000 will be payable at *one month* after date, viz. :—on the 17th March, 1910.

3. *The Tenders must specify the net amount per cent. which will be given for the amounts applied for, and the Tenders of private individuals must be made through a London Banker.*

4. The Bills will be issued and paid at the Bank of England.

5. The persons whose Tenders are accepted will be informed of the same on Tuesday, the 15th instant, and payment in full of the amounts

of the accepted Tenders must be made to the Bank of England not later than three o'clock on Thursday, the 17th February, 1910.

6. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

LIGHT RAILWAYS ACT, 1896.

The Board of Trade have recently confirmed the undermentioned Order made by the Light Railway Commissioners :—Clayton West and Darton Light Railway (Extension of Time and Amendment) Order, 1910, reviving the powers granted by the Clayton West and Darton Light Railway Order, 1906, for the compulsory purchase of lands, and extending the periods limited by that Order for the same and for the completion of the railway and works thereby authorised, and for other purposes.

RAILWAY EMPLOYMENT (PREVENTION OF ACCIDENTS) ACT, 1900.
