## PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.

NOTICE is hereby given, that the Local Government Board by their Order, dated the 3rd day of February, 1910, have directed :--

1. That on and after the 17th day of March, 1910-

Sections 23, 25 and 33 comprised in Part II; Sections 34, 35, 36, 37, 38, 43, 44, 45, 46 and 49 comprised in Part III; and

and 49 comprised in Part III; and Sections 52, 53, 54, 55, 56, 57, 58, 60, 61, 62, 63, 64, 65 and 68 comprised in Part IV

of the Act of 1907 shall be in force in the several contributory places within the Liskeard Rural District.

2. That until the Local Government Board shall otherwise order, section 35, so far as it relates to the deposit of material, shall have effect, subject to the first proviso to section 91 of the Public Health Act, 1875, and that byelaws made in pursuance of section 16 of the Local Government Act, 1888, for the prevention and suppression of nuisances shall not, in relation to any subject-matter of this section, be of any force or effect in any contributory place within the district, and also that as regards section 38, nothing in this section shall prejudicially affect any power or right exerciseable by or attaching to an owner or occupier of premises by virtue of section 22 of the Public Health Act, 1875, or of section 18 of the Public Health Acts Amendment Act, 1890.
