## ORDER OF THE REGISTRAR-GENERAL IN ENGLAND.

#### (Dated 23rd February, 1910.)

Whereas by the 21st section of the Births and Deaths Registration Act, 1874, it is enacted that the Registrar-General, with the sanction of the Local Government Board, may from time to time alter Registration Sub-Districts :---

1. And whereas it is expedient (1) in order that the Sub-districts of Leeds Registration District may all eventually consist of entire Wards of Leeds County Borough, (a) that the part of Brunswick Ward now situated in Chapeltown Sub-district should be transferred to West Leeds Sub-district; (b) that the part of Headingley Ward now situated in Chapeltown Subdistrict should be transferred to Kirkstall Subdistrict; (c) that the part of the North Ward now situated in Chapeltown Sub-district should be transferred to North Leeds Sub-district; (d) that the part of the North-West Ward now situated in Chapeltown Sub-district should be transferred to West Leeds Sub-district; (e) that the part of the North-East Ward now situated in North Leeds Sub-district should be transferred to Chapeltown Sub-district; (f) that the part of the Central Ward now situated in West Leeds Sub-district should be transferred to North Leeds Sub-district; and (2) that Chapeltown Sub-district should in future be called and known as North-East Leeds Sub-district;

2. Now, therefore, I, Bernard Mallet, Registrar-General of Births, Deaths, and Marriages in England, in exercise of the powers given me by the above mentioned Act, and with the sanction of the Local Government Board, do hereby order and declare that the foregoing alteration shall take effect accordingly.

3. This Order shall come into operation on 1st day of April, nineteen hundred and teu.
