Act which is cited by reference to its short title in the first column of the second schedule to this Order shall, to the extent specified in the second column of that schedule, be no longer in force in the district.

(2) Where an enactment in a Local Act, other than an enactment specified in the second schedule to this Order, contains provisions which alter, amend, apply, or otherwise relate to an enactment so specified, those provisions shall, to the extent to which they are inconsistent with any section or Part to which Article I of this Order applies, be no longer in force in the district.

ARTICLE III.—Within the period of three weeks immediately following the date of this Order, or, where in Our opinion the circumstances so require, within such later period as We by Order prescribe, the Local Authority shall cause this Order to be published by advertising the same once at least in one or more of the newspapers circulating in the district, and shall also cause a statement of the effect of this Order to be published in the London Gazette.

ARTICLE IV.—This Order shall come into operation on the twenty-first day of June, one thousand nine hundred and ten.
