the Managers of Metalliferous Mines should be compelled to hold such certificates, and whether certificates granted by Colonial Governments should not be accepted in this country; and

What steps could be taken for the better prevention of Accidents in Quarries.

And whereas We have deemed it expedient that a further Commission should issue to inquire into and report on the health and safety of persons employed in Metalliferous Mines and Quarries, and also to deal with any matter in relation to Metalliferous Mines and Quarries which was referred to the Commissioners appointed by the aforesaid Royal Warrant of the eighteenth day of May, one thousand nine hundred and seven:

Now know ye that We do by these Presents determine the powers of the Commissioners appointed as aforesaid so far as they relate to Metalliferous Mines and Quarries, and do further by these Presents nominate, constitute, and appoint you the said Sir Henry Hardinge Samuel Cunynghame (Chairman); Richard Augustine Studdert Redmayne; John Scott Haldane; John Stirling Ainsworth; Richard Methuen Greaves; Richard Arthur Thomas; Robert Thomas Jones; William Lewney and Uriah Lovett to exercise the said powers, and also to inquire into and report on questions relating to the health and safety of persons employed in Metalliferous Mines and Quarries.

And for the better effecting the purposes of this Our Commission, We do by these Presents give and grant unto you, or any three or more of you, full power to call before you such persons as you shall judge likely to afford you any information upon the subject of this Our Commission; and also to call for, have access to and examine all such books, documents, registers and records as may afford you the fullest information on the subject, and to inquire of and concerning the premises by all other lawful ways and means whatsoever:

And We do by these Presents authorize and empower you, or any three or more of you, to visit and personally inspect such places as you may deem it expedient so to inspect for the more effectual carrying out of the purposes aforesaid:

And We do by these Presents will and ordain that this Our Commission shall continue in full force and virtue, and that you, Our said Commissioners, or any three or more of you, may from time to time proceed in the execution thereof, and of every matter and thing therein contained, although the same be not continued from time to time by adjournment:

And We do further ordain that you, or any three or more of you, have liberty to report your proceedings under this Our Commission from time to time if you shall judge it expedient so to do:

And Our further will and pleasure is that you do, with as little delay as possible, report to Us, under your hands and seals, or under the hands and seals of any three or more of you. your opinion upon the matters herein submitted for your consideration: :

## PRESENT,

The KING's Most Excellent Majesty in Council.

HEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the thirty-third and thirty-fourth years of Her late Majesty Queen Victoria, chapter thirtynine, and of the Acts therein mentioned, that is to say, the Act of the third and fourth years of Her said late Majesty, chapter one hundred and thirteen, the Act of the fourth and fifth years of Her said late Majesty, chapter one hundred and the Act of the thirty-first and thirty-second years of Her said late Majesty, chapter one hundred and fourteen, duly prepared and laid before His late Majesty King Edward the Seventh in Council a scheme bearing date the twenty-first day of April, in the year one thousand nine hundred and ten, in the words following, that is to say :—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the thirtythird and thirty - fourth years of Her late Majesty Queen Victoria, chapter thirty-nine, and of the Acts therein mentioned, that is to say, the Act of the third and fourth years of Her said late Majesty, chapter one hundred and thirteen, the Act of the fourth and fifth years of Her said late Majesty, chapter one hundred and the Act of the thirty-first and thirty-second years of Her said late Majesty, chapter one hundred and fourteen, have prepared and now humbly lay before Your Majesty in Council the following scheme for effecting a transfer of the ownership of the advowson or perpetual right of patronage of and presentation to the church and cure (hereinafter called 'the said benefice') of Saint Wilfrid, Cuckfield, in the county of Sussex and in the diocese of Chichester.

"Whereas the advowson or perpetual right of patronage of and presentation to the said benefice of Saint Wilfrid, Cuckfield, is vested in the Vicar or Incumbent for the time being of the vicarage of Cuckfield, in the said county of Sussex and in the said diocese of Chichester:

"And whereas the Reverend Robert Fisher, Vicar or Incumbent of the said parish of Cuckfield, is desirous that the whole advowson or perpetual right of patronage of and presentation to the said benefice of Saint Wilfrid, Cuckfield, now vested in him as aforesaid, as such Vicar or Incumbent, should be transferred to and be vested in the Right Reverend Charles John, Bishop of Chichester, in right of his See.

"And whereas the said Charles John, Bishop of Chichester, is willing to accept such transfer, and in token of such his willingness, and also in token that the same transfer has that consent of the Bishop which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary, he, the said Charles John, Bishop of Chichester, has executed this scheme as hereinafter mentioned.

"And whereas it appears to us that the transfer of the patronage of the said benefice of Saint Wilfrid, Cuckfield, which is hereinbefore mentioned and hereinafter recommended and proposed, will tend to make better provision for the cure of souls in the parish or district in or in respect of which the right of patronage or advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the new parish of Saint Wilfrid, Cuckfield.
