hour;

And whereas, the County Council of Essex having applied to Us to make Regulations in pursuance of the said sub-section putting the above-mentioned provisions of that sub-section in force within the limits comprising parts of certain roads within the Urban District of Romford, We caused a Local Inquiry to be made by one of Our Inspectors into the subjectmatter of that application, and the Report of the Inspector has been received and considered by Us:

Now therefore, in pursuance of the powers given to Us in that behalf, We do, by this Our Urder, make the following Regulations:---

The provisions of sub-section (1) ARTICLE I.of section 9 of the Act with respect to the driving of a motor car at a speed not exceeding ten miles per hour shall apply and have effect within the limits comprising the parts of roads within the said Urban District which are specified in the Schedule hereto.

ARTICLE II.-These Regulations shall come into operation on the fourth day of July, one thousand nine hundred and ten.

SCHEDULE.

So much of the main road from London to Colchester (including High-street) as extends from its junction with St. Andrews-road to a point opposite the eastern extremity of the churchyard of St. Edward the Confessor's Church ;

So much of North-street as extends from its junction with the main road aforesaid to a point opposite the southern extremity of the Almshouses belonging to Reede's Charity; and

So much of South-street as extends from its junction with the main road aforesaid to a point opposite the southern extremity of the premises attached to the Police Station.

MOTOR CAR ACT, 1903.

ORDER of the Local Government Board: District Auditors Act, 1879; Assignment of **Duties and District.**

CUMBERLAND AUDIT DISTRICT.

To Geoffrey St. John Hibbert ;--

- To the Guardians of the Poor of the several Poor Law Unions named in the Schedule to this Order ;---
- To the Overseers of the Poor of the several Parishes comprised within the said Unions respectively;-
- To the Authorities referred to in Article I (3) of this Order;—

And to all others whom it may concern.

Whereas by Section 4 of the District Auditors Act, 1879, it is enacted that the Local Government Board may from time to time assign to District Auditors their Duties, and the Districts in which such Auditors respectively are to act, and may from time to time change wholly or in part such Duties or Districts ;

And whereas Geoffrey St. John Hibbert has been duly appointed under the provisions of the Statutes in that behalf to be a District Auditor;

Now therefore, We, the Local Government Board, hereby certify the appointment to the office of District Auditor of the said Geoffrey St. John Hibbert (hereinafter referred to as "the District Auditor"), and do Order and Prescribe as follows :---

ARTICLE I.-It shall be the duty of the District Auditor to audit the Accounts of the following Authorities and their Officers; namely,-

- (1) The Guardians of the Poor of the several Poor Law Unions named in the Schedule to this Order.
- (2) The Overseers of the Poor of the several Parishes comprised in the said several Unions.
- (3) The several other Authorities for the time being whose Accounts are or may be by law subject to be audited by a District Auditor, and whose Districts or the areas of whose jurisdiction are for the time being wholly situated within one or more of the said
