June, in the year one thousand nine hundred and ten, in the words following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifth and sixth years of Her late Majesty Queen Victoria, chapter one hundred and eight, and of the Act of the twenty-first and twenty-second years of Her said late Majesty, chapter fifty-seven, which Acts are known as 'The Ecclesiastical Leasing Acts,' have prepared and now humbly lay before Your Majesty in Council the following scheme relating to the vicarage and parish of Pannal, in the county of York and diocese of Ripon.

"Whereas the annual value of the benefice of Pannal, that is to say, of the vicarage of the parish of Pannal aforesaid (hereinafter called the said benefice), has been improved by means of certain sales and leases of the glebe lands of the said benefice effected under the authority of the said Acts by the Vicar or Incumbent of the said benefice of Pannal.

"And whereas the net proceeds of the said sales have been paid to us, the said Ecclesiastical Commissioners, and have from time to time as the same have been received by us been invested in accordance with the provisions in that behalf contained in the said Acts and of such investments there are standing in the name of us, the said Ecclesiastical Commissioners, first, a sum of five thousand one hundred and seventyseven pounds ten shillings and five pence India three pounds per centum stock, and second, a sum of two thousand nine hundred and ninetynine pounds seven shillings and eleven pence London County three pounds per centum stock, both which said sums of stock are now held by us in trust to pay the Vicar or Incumbent for the time being of the said benefice the annual interest or dividends from time to time arising or accruing therefrom or thereupon but subject nevertheless to the provisions contained in the said Acts with respect to making a certain portion of the improved value arising to the said benefice from the said sales and leases payable to us for the benefit of our common fund to be applied as in the said Acts mentioned.

"And whereas the improvement in the annual value of the said benefice arising from or by means of the said sales and leases exceeds the annual sum of three hundred and fifty pounds and after the appropriation hereinafter recommended to us, the said Ecclesiastical Commissioners, for the benefit of our common fund of the sum of stock hereinafter mentioned the average annual income of the said benefice will not be left at a less sum than three hundred pounds.

"And whereas the Reverend Mark Rowntree, Clerk in Holy Orders, is the present Vicar or Incumbent of the said benefice.

"Now therefore we, the said Ecclesiastical Commissioners, humbly recommend and propose that upon the vacation of the said benefice by the said Mark Rowntree the sum of stock secondly hereinbefore mentioned, that is to say, the sum of two thousand nine hundred and ninety-nine pounds seven shillings and eleven pence London County three pounds per centum stock, shall cease to be held by us for the benefit of the Vicar or Incumbent of the said benefice and shall be held by us for the benefit of our common fund to be applied as in the said Acts mentioned.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of either of them or of any other Act of Parliament."

And whereas the notice of the foregoing scheme, which is required by the hereinbefore mentioned Acts, has been given by the said Commissioners to the Patrons of the said benefice of Pannal, and the said Patrons have not made any objection to the said scheme.

And whereas the said scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts. And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Ripon.

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His late Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her late Majesty Queen Victoria, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, have prepared and now humbly lay before Your Majesty in Council the following representation as to the assignment of a district chapelry to the consecrated church of Saint John, situate at Miskin, in the new parish (sometime consolidated chapelry) of Saint Margaret, Aberdare (otherwise Mountain Ash), in the county of Glamorgan and in the diocese of Llandaff.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint John, situate at Miskin as aforesaid.

"Now, therefore, with the consent of the Right Reverend Joshua Pritchard, Bishop of Llandaff (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent that it would, in our opinion, be expedient that all that part of the said new parish of Saint Margaret, Aberdare (otherwise Mountain Ash), which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint John, situate at Miskin as aforesaid, and that the same
