

underclothing and bedding from Kertch and Yenikale are prohibited.

Luggage brought by travellers with them shall be included in this prohibition so far as bedding and underclothing are concerned.

This prohibition shall not apply :

I. As regards importation and transit :

To goods which have arrived from Kertch and Yenikale, but which can be shown to have come from elsewhere, and which are packed in such a manner as to render it impossible that they should have been in contact with infected objects ;

II. As regards transit :

To goods which are packed in such a manner that they cannot undergo any operation of manufacture on the way.
