

the alteration and extension of the objects of the Company proposed to be effected by resolutions passed on the 26th May, 1910, and confirmed on the 16th June, 1910, to the effect following, namely:—

1. That the provisions of the Memorandum of Association of the Company with respect to the Company's objects be altered as follows, viz:—

(A) By cancelling the following words in Clause III thereof, viz:—In sub-clause 1 "in the Australian Colonies," in sub-clause 3 "in and with the said Colonies," in sub-clause 4 "in any or either of the Australian Colonies," in sub-clause 5 "into any or either of the said Colonies," and "the Colonial," in sub-clause 6 "in the said Colonies," in sub-clause 9 "whether English or Australian," and in sub-clause 10 "in connection with the said Colonies or either of them," and

(B) By inserting the following words in Clause III thereof, viz:—In sub-clause 3 after the word "estates, lands and properties of all descriptions"; and at the end of sub-clause 6 the words "or other security," and by inserting immediately after sub-clause 10 the following, viz:—

"11. To do all or any of the above acts, matters and things in or in connection with all parts of the world."

2. That when and so soon as the above alterations in the Company's Memorandum of Association shall have been confirmed by the Court, the name of the Company be altered to "The Australian, Mercantile, Land and Finance Company Limited," or to such other name as the Court may approve.

And further take notice that such petition is directed to be heard before his Lordship Mr. Justice Neville, on the 4th day of November, 1910, and any person interested in the said Company, whether as debenture stock-holder, creditor, or otherwise, desiring to oppose the making of an Order for so altering the Memorandum of Association of the Company under the above Act, should appear at the time of hearing by himself, or his Counsel, for the purpose, and is requested to send notice of such desire, with the grounds of his or her objection, to the Secretary of the Company, Mr. H.
